On the Council Agenda for 31 October, 1977 there is a letter received from Miss Pauline Mudrakoff. In Miss Mudrakoff's letter she enumerates some things that happened relative to Local Improvement Works in the 3700 Blk. Albert.

It was not clear to the Engineering Department from Miss Mudrakoff's letter if she was asking that the 3700 Blk. Albert be included in a future Local Improvement Program with only curbs and paving. Because the letter was unclear in this matter Miss Mudrakoff was contacted in the evening by the Engineering Department's Construction Programmer to clarify the matter.

Miss Mudrakoff informed the Construction Programmer that several points had been raised regarding Local Improvement Work in the 3700 Blk. during the Public Hearing on 18 October, 1977 relative to Rezoning No. 38/77. Miss Mudrakoff spoke to the points raised at the hearing but was not sure that she had clarified the sequence of events. Reflecting after the meeting, Miss Mudrakoff thought it would be advisable to set down, in writing to the Mayor and Council for their information, the sequence of events concerning Local Improvement in the 3700 Blk. Albert. Miss Mudrakoff's letter is therefore meant to serve as a record memo for the Mayor and Council.

Further for Council's information, the 3700 Blk. Albert (north side) was the subject of a Council Initiative in 1971 for paving and curb sidewalks. This Initiative was defeated by the residents.

In further discussions with the Programmer as to the residents' wishes concerning future Local Improvement Works, Miss Mudrakoff indicated that they, the residents, would prefer to wait and see for the time being the results of Rezoning 38/77. Miss Mudrakoff further indicated that she would be in contact with the Construction Programmer at a later date to discuss the matter of Local Improvement Works on the 3700 Blk. Albert.
