Re: PETITION FOR CONSTRUCTION OF A LANE BOUNDED BY BURRIS STREET,  
WALKER AVENUE, LEIBLY AVENUE AND STANLEY STREET.

Appearing on the agenda for the June 6, 1977 meeting of Council is a sufficiently signed lane construction and paving petition covering part of the subject lane.

Following Council's repeal of the relevant portion of By-law No. 4863 staff would proceed to prepare a certificate of sufficiency and a financial report as required under Section 601 of the Municipal Act.

RECOMMENDATION:

1. THAT Council authorize the deletion of the northern portion of the subject lane from By-law No. 4863 as more specifically noted in the Director of Planning's report.

BACKGROUND

In December of 1965 a portion of the above noted lane as shown on the attached sketch was stopped up and closed to traffic by the passage of By-law No. 4863 this being "Burnaby Road Closing By-law No. 8, 1965." Prior to and at that point in time, lane construction was not possible since the lane was insufficient in width along that portion abutting lots 182 and 183. As a result of the subsequent subdivision creating Lots 182 and 183 the lane was widened to its present size thus allowing the construction of approximately one-half of the lane's total length.


PRESENT SITUATION

Currently appearing on this agenda is a petition, from owners within the subject block, requesting the construction and paving of the lane along the 20' wide portion of the lane. However, prior to the implementation of this work, it is necessary that By-law No. 4863 be amended to delete that portion of the lane which is to be constructed.

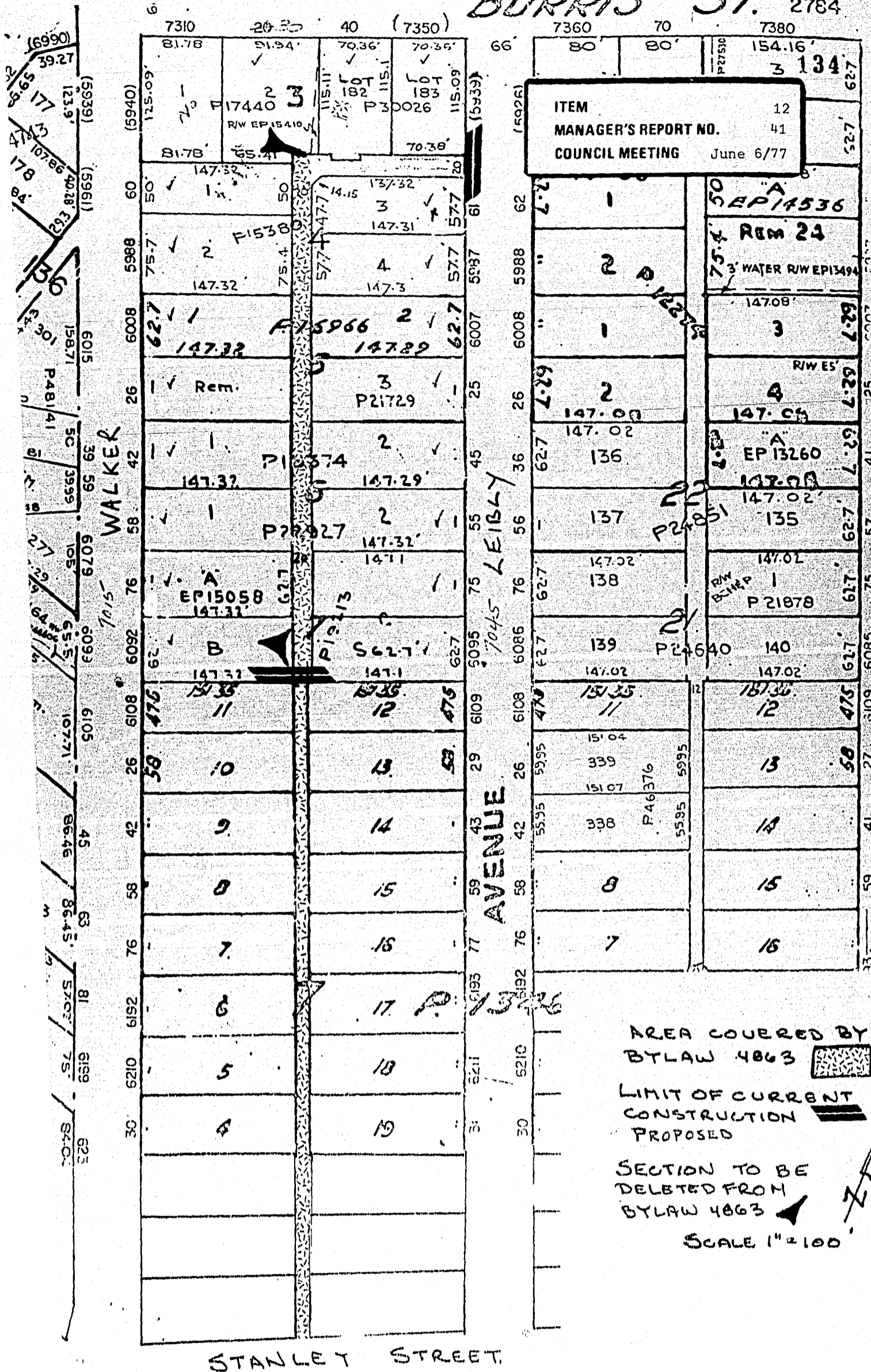
RECOMMENDATION
