a) R.L. Loewen, M.L.A., Burnaby-Edmonds, Re: 1978 B.C. Summer Games

Correspondence under date of August 19, 1977 was received advising in part that Burnaby has received an invitation to bid to host the 1978 B.C. Summer Games and that Mr. Elwood Veitch, M.L.A. for Burnaby-Willingdon and Mr. Loewen would be pleased to support Burnaby's application and that the applications are supposed to be in by September 21st, 1977.

The Municipal Manager provided a report advising therein that on April 18 in Manager's Report Item #5, the Council was advised that the Parks and Recreation Commission had considered the proposition by Mayor Constable that the staff examine and report back on the question of Burnaby making application to host the first B.C. Summer Games. The Commission tabled the matter pending receipt of the Provincial Guidelines for the Games. The comprehensive guidelines have been referred to the Parks and Recreation Administrator who will prepare a report for the consideration of the Commission and the Commission subsequently will submit its comments on this matter to Council.

b) R.L. Foster

'In summary I will concede that there are a few streets that are very poorly lighted and if you wish to upgrade them on the basis of dire need initiated by a REQUEST FROM THE RESIDENTS, then so be it, but lighting a whole area to gross excess whether needed or not-you must have lost your senses completely.'

The Municipal Manager provided a report from the Municipal Engineer advising in part that our present standard for residential streets is lights on only one side of the street. On collector streets our standard is lights on both sides of the street but staggered to give a better light distribution pattern.

d) J.W. Huff Re: Subdivision Reference #138/74 - Lougheed Highway and Phillips Avenue - Landscape Buffer

Correspondence under date of August 26, 1977 was received pointing out that Mr. Huff cannot agree (and his neighbours are of the same feeling) that the 40' buffer frontage of the Lougheed cannot sit incomplete until all the homes in the development are sold.

The Municipal Manager provided a report from the Director of Planning advising therein in part that the existing situation is that the Planning Department on April 5, 1977 wrote to the developer, DeCourcy Developments Ltd. requesting a projected date for completion of the work and received the reply that they were awaiting completion of all the houses. The Planning Department has received no reply, however, to their more recent letter of June 3rd, 1977 to DeCourcy requesting that they begin work immediately on the buffer. As a result of this it has been arranged that the Parks Department engage a landscape contractor to perform the works and that the letter of credit be drawn upon in the amount of the contract. It is expected that this work will be completed by early fall.

The Director further advised that the applicant has the right to reapply, and in the event that the District of Burnaby wishes to object to such an application, it will be necessary for the District of Burnaby to establish their position at that time.

This correspondence was received by the Council.

- f) Mayor Constable placed before the meeting, correspondence dated August 30, 1977 received from the Minister of Highways and Public Works, the Honourable Alex V. Fraser in reference to the Oakalla property advising therein that the following are the terms of reference for the committee to be struck to study the Oakalla land in Burnaby:
 - The committee should recommend a phase by phase dismantling of the present Oakalla site, together with recommendations for the proper use and disposition of those lands as they become available.
 - 2. The Committee should recommend to the government the best possible use and disposition of those portions of land adjacent to Burnaby Lake and Royal Oak Avenue in Burnaby now now being used in connection with the prison. The recommendations could be consistent with proper use and the aims and aspirations of the citizens of Burnaby.

The correspondence further advised that this will be a citizens' committee made up of six people and chaired by the M.L.A. for the area, Elwood Veitch and that the Minister of Highways and Public Works would appreciate it if Mayor Constable would appoint one member of the Burnaby Council to this committee and that the committee will be totally voluntary with the Ministry supplying the secretarial help where necessary.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN RANDALL:

"THAT the correspondence dated August 30, 1977 from the Minister of Highways and Public Works in reference to Oakalla property be received."

TABLED MATTER

a) Correspondence was received from the Minister of Human Resources under date of August 24, 1977 advising therein that the said Minister has now had the opportunity to fully assess the financial impact of the six point proposal of the Downtown Eastside Residents' Association and that the recommendations would involve an increase of 18 cents per capita per month to the District of Burnaby.

The correspondence showed the per capita charges that would result based on the size of the municipality.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN DRUMMOND:

"THAT the correspondence from the Minister of Human Resources dated August 24, 1977 in reference to the financial impact of the six point proposal by the Downtown Eastside Residents' Association be received."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN DRUMMOND:

"THAT this subject matter be now lifted from the table."

CARRIED UNANIMOUSLY

Alderman Drummond advised that there were only five recommendations now as the recommendation, 'to increase the comfort allowances for recipients in institutions had been looked after as the said comfort allowances have been increased.

The five recommendations that were now on the table are as follows:

"THAT the Ministry of Human Resources be urged to use the \$100,000,000. under expenditure in the Human Resources Department budget to raise the basic rate for handicapped persons and those aged sixty to sixty-four to \$ 284.00 per month; for singles \$ 230.00 per month and for couples to \$ 340.00 per month, to tie rates to the cost of living; to eliminate the four month waiting period for increased rates of assistance; and to make all recipients eligible for total shelter and utility allowance."

A vote was then taken on the five recommendations and CARRIED

OPPOSED: Aldermen Emmott, Lewarne, Stewart and Stusiak.

ENQUIRIES

Alderman Lewarne

With reference to Metric Conversions, Alderman Lewarne enquired as to whether all school signs are being changed to kilometres per hour for the speed limit or whether consideration had been given to keeping dual signs up.

The Municipal Engineer advised that to be consistent and avoid confusion, all municipalities have followed the Provincial Government lead and erected metric signs.

Alderman Randall

Alderman Randall enquired as to whether a map had been forwarded to the Liquor Control and Licensing Branch in reference to neighbourhood pub locations in Burnaby.

The Assistant Director - Current Planning advised that a letter and a blank map requesting detailed information as to neighbourhood pub locations in Burnaby had gone forward to the Liquor Control and Licensing Branch.

Alderman Randall pointed out that a neighbourhood pub site must still be approved by the General Manager of the Liquor Control and Licensing Branch.

Alderman Stusiak

Alderman Stusiak advised that September 1st has passed and enquired as to whether the Canadian Union of Public Employees, Local 23 has given notice that they wish to renew or open their collective agreement with the Municipality.

The Municipal Manager was of the opinion that the time frame was not up until the end of September.

Alderman Stusiak advised that he would like to see the Municipality come to the contract bargaining date with some bargaining behind us rather than all before us.

Mayor Constable advised that he will discuss this with the Municipal Manager and the Labour Relations Committee of the Greater Vancouver Regional District.

Alderman Lawson

Alderman Lawson advised that she wished to challenge the right of Mayor Constable to cut off discussion before the question had been put.

Alderman Lawson cited Section 17 of the "Burnaby Procedure By-law 1971" being By-law No. 6023, as amended, which reads in part," after a question is put by the Mayor, no member shall speak to the question".

Alderman Lawson advised that the question had not been put and any member of the Council should have the right to speak once and she did not have that right.

Mayor Constable advised that he did give every member of Council the right before he recognized Alderman Drummond and he would not recognize any person that has spoken once unless everybody else wishing to speak has been heard first, then he would allow the person to speak twice. In this case some members of Council spoke, Alderman Drummond indicated that he wanted to speak, Mayor Constable advised that he ignored Alderman Drummond until everybody else had spoken and that there was no one else who had indicated they wanted to speak and then his Worship stated that he was allowing Alderman Drummond to wind up the debate.

Alderman Lawson advised that she was aware of this but in essence this is in fact breaking the by-law of Council because the procedure by-law states that after a question is finally put by the Mayor no member shall speak to the question but the Mayor had not called for the question.

Following further discussion, Alderman Lawson withdrew her challenge to the Mayor's decision and the subject matter was referred to the Municipal Clerk for an answer - that is, that after the chair has ruled that a certain alderman is summing up whether the Chair then has the right to hear someone else.

Alderman Stusiak

Alderman Stusiak reported that under the heading "Transit Vehicles" being a report from the Provincial Department of Municipal Affairs for the period ended December 31, 1976 - page 31 - it states that no new vehicles were ordered in 1976.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN DRUMMOND:

"THAT we ask of the Minister of Municipal Affairs whether in effect this means that there is no further expansion to the bus fleet as the Council would be interested to know this."

CARRIED UNANIMOUSLY

Alderman Stusiak;

Alderman Stusiak enquired of the Municipal Manager as to whether he had heard from Stuttgart on the water falls.

The Municipal Manager advised that he had not received a reply as yet.

Alderman Lewarne

Alderman Lewarne enquired of his Worship, the Mayor as to the status of the Kensington Overpass grant.

Mayor Constable advised that he will be meeting with the Honourable O.E. Lang the Federal Minister of Transport this coming Friday.

Alderman Randall

Alderman Randall enquired as to whether correspondence dated August 25, 1977 addressed to the individual members of Council in reference to "1977 Taxes - Greentree Village Community Centre, 4295 Garden Grove Drive, Burnaby, B.C." would be on the agenda for the next regular meeting of Council.

The Clerk was directed to place this correspondence on the agenda for the Council meeting of September 12, 1977.

Residential Occupancy Standards
