To date, all approvals have been obtained with the exception of C.P. Rail. In recognition of certain past difficulties with reclamation projects adjacent to the railway, C.P. Rail has placed stringent requirements on the measures to be incorporated in the reclamation, on the type and quality of the fill material, provision for drainage, fencing and liability for any damage resulting from the reclamation. Negotiations have been conducted on these items resulting in the preparation of a draft legal agreement which is currently being analyzed by staff.

The Municipal Solicitor has certain reservations on the wording of the agreement and on the liability which would be assumed by the Corporation. A response has been prepared outlining proposed revisions which will be forwarded to C.P. Rail.

This matter is one which must be given careful consideration, as the formal agreement must provide sufficient safeguards for the Municipality as well as for C.P. Rail.
