a) Mr. Anthony G. Boroevich, 7122 Buffalo Street, then addressed Council and spoke in opposition to the recommendation of the Municipal Manager as contained in Item 17, Municipal Manager's Report No. 38, 1978 May 15 which will be considered by Council later this evening.

Mr. Boroevich noted that he had appeared as a delegation before Council on 1978 May 08 on this subject at which time he had presented a petition signed by all of the residents of Buffalo Street objecting to the proposed future extension of Buffalo Street from Bainbridge Avenue to Phillips Avenue. Mr. Boroevich reiterated remarks which he had made on this subject at that time. Mr. Boroevich was particularly concerned with the traffic patterns which he was sure would be established by shortcutting traffic between the Lougheed Highway and Winston Street should Buffalo Street be extended from Bainbridge Avenue to Phillips Avenue.

b) Mr. William Manning then addressed Council and advised that he was speaking as a representative of the citizens living on Sprott Street in connection with the proposed classification of a section of Sprott Street as a temporary truck route. Mr. Manning noted that on May 08, quite by chance, he had learned that this subject would be considered by Council that evening leaving him no opportunity to express an opinion in this regard. He had contacted Aldermen Drummond, Emmott and Mercier and the matter had been tabled for consideration until this evening. Mr. Manning was of the opinion that the six or seven months proposed for the temporary classification of this portion of Sprott Street as a truck route was too long particularly in view of the fact that an alternative routing was available. Mr. Manning was also of the opinion that the residents of Sprott Street should have been notified well in advance of the proposal to classify this portion of Sprott Street as a truck route.

c) Mr. John F. Adams, President, Norland Avenue Property Owners Association, then addressed Council in support of the proposal to temporarily classify Sprott Street, between Douglas Road and Highway No. 1 as a temporary truck route. Mr. Adams was of the opinion that this action was necessary to provide a safety factor for truckers unfamiliar with the area who find it impossible to use Norland Avenue due to the construction work. In such cases, the trucker could continue up Sprott Street to Douglas Road, north on Douglas Road to the intersection of Norland Avenue and Douglas Road. This is by far the shortest and most expeditious method of a trucker reaching his destination on Norland Avenue.

d) Mr. B.A. Mathie, Canadian Pro-Am Skateboard Association then addressed Council and requested authority to use Macpherson Avenue from Beresford Street to Watling Street for skateboarders on Sundays from May to August inclusive between the hours of 10:00 h and 14:00 h.

Mr. Mathie pointed out that Macpherson Avenue at this location is in an industrial area in South Burnaby. Macpherson Avenue does not have a heavy traffic flow, it involves approximately 300 yards of road from Watling Street to just below Beresford Street. Mr. Mathie pointed out that there is sufficient room through the described section of road that any traffic flow need not be impeded while the skateboard activity is being conducted. Additional aids for the motorists such as barricades or patrol personnel could be employed if it were necessary. In the event of poor weather all activity would be cancelled. Mr. Mathie stressed that the aim of the Canadian Pro-Am Skateboard Association was to conduct all their activities with safety the foremost factor. All the competitions are run under tight safety supervision and all contestants must pass their boards through a technical inspection to ensure safe running. Safety gear (helmet, elbow pads, knee pads, gloves and proper footwear) must be worn to participate. The association's accident free record speaks for itself.

e) Mrs. Alice A. Orr then addressed Council on behalf of the immediate residents of the area Graham Avenue and Seventh Street expressing opposition to the development of a proposed Mini tot lot at 7793 Graham Avenue. Mrs. Orr presented petitions containing approximately 180 signatures in support of her presentation. Mrs. Orr was of the opinion that there was a definite lack of support from the immediate neighbourhood residents for this park. This opposition had been

raised at Neighbourhood Improvement Program meetings but to no avail. The people who pushed for this park are not the ones that will have to live with the problems that will be created by it. In the immediate area of the proposed park there were very few tots. Mrs. Orr pointed out that there was an existing park on Graham Avenue bounded by 16th Avenue, Sixth Street and Fourth Street which is completely undeveloped. Mrs. Orr was of the opinion that this proposed tot lot would only add to the existing youth oriented problems in the area. Mrs. Orr requested Council to reconsider all aspects of this proposed development before continuing with the project which the majority of the immediate area residents did not wish in the first place.

Council was advised that a staff report on this subject would be available on 1978 May 23 and further consideration of this subject was deferred until that time.

f) Mrs. Katherine Isaacson then addressed Council and urged that the recent decision to deny an application for a grant from the Mountain Dance Theatre in the amount of \$2,000. be reconsidered. Mrs. Isaacson was of the opinion that the service provided by the Mountain Dance Theatre to the Municipality of Burnaby was unique and almost irreplacable. The contribution of the Mountain Dance Theatre to the culture of the Municipality was beyond question and could not be compared with other sporting activities such as swimming, baseball, etc. Mrs. Isaacson considered that if the Mountain Dance Theatre was obliged to cease operations due to lack of financial support the loss to the Municipality would be immeasurable.

His Worship, Acting Mayor Ast advised Council that under the authority granted him in Section 180(1) of the Municipal Act he was returning the question of a grant to the Mountain Dance Theatre to Council for reconsideration.

In doing this, it excludes reference to grant programs not affecting the mill rates and makes no mention of social welfare or the homeowner grant programs, which need some explanation in a paper dealing with the fiscal assistance provided by the Province, if such a paper is to be forwarded to the Province.

Under the circumstances, it is respectfully suggested that in fairness to the Provincial Government and to ourselves, Item 18 should be rewritten to show all Provincial grant and cost sharing programs as enjoyed by Burnaby.

The revised report affirms the point made in the original report that increases in assistance to the municipal mill rate are more than offset by reduction in assistance to the school rate. However, it sets out all government grant and cost sharing programs fairly and will be most informative to all who read it. It should be of special interest to the M.L.A.s representing Burnaby.

The Municipal Manager recommended:
