3. THAT Council approve the execution of an agreement with each firm.

REPORT

At its meeting of 1978 December 11 and 1978 November 27 respectively, the Council approved the funding to proceed with the construction of Pavilion and Service Building at the Barnet Marine Park and a new Pro Shop at the Burnaby Mountain Golf Course.

Further to this approval, the Parks and Recreation Commission received a report at a Special Meeting on 1978 December 13, from the Chief Building Inspector and the Parks and Recreation Administrator including the following list of Architects for consideration.



The staff recommendation was for the appointment of Mr. Peter F. Smith in view of his involvement with the design of the original Golf Course Pro Shop.

In reviewing this matter, the Commission were mindful of the fact that Downs-Archambault and IBI Group were close runners up in the design competition for the Eastburn Community Centre which was awarded to Calberg Jackson Partners. In particular, the apparent ability of Downs-Archambault to make their buildings fit into the surrounding landscape was considered appropriate for the needs of Barnet Marine Park where this aspect would be particularly advantageous.

Therefore, in recognition of this fact and Peter F. Smith's former involvement with Golf Course, the Commission recommended the appointment of both firms as indicated.
