PRESENTATION

Norah Code, Musical Director, Burnaby Rascals, then advised that the Burnaby Rascals were present at the Council Meeting this evening to present to the Acting Mayor, on behalf of Council, a copy of the group's first long play record, "Here We Are Again". Mrs. Code then introduced Mr. Fred Spain, who is the eldest member of the Burnaby Rascals, to make the presentation of the record to the Acting Mayor.

Mr. Spain stated that he had been given the honour of making this presentation to His Worship, Acting Mayor Ast, on behalf of the Burnaby Rascals, a volunteer group of senior citizens dedicated to providing entertainment to hospitals, nursing homes, and other places where there are shut-ins. The chief aim was to give a lift to these less fortunate people, not only in Burnaby but also in the city and the country too. For three consecutive summers the group has taken tours of Central B.C. and were highly favoured to be representatives of Burnaby on the Goodwill Visit to New Brunswick four years ago. The Burnaby Rascals take great pleasure in presenting to Council this record "Here We Are Again" as a friendly challenge and a labour of love. Mr. Spain expressed appreciation of the Burnaby Rascals for the use of the room at Bonsor for their practices. Mr. Spain also expressed the wish that the record would be accepted as a token of appreciation and goodwill which will bring prestige to Burnaby. Mr. Spain then concluded his presentation by presenting the record from the Burnaby Rascals to another group of Rascals, Burnaby Council.

A letter dated 1978 June 11 was received protesting the proposed acquisition of a portion of the property located at 5992 Olive Avenue amounting to 32 feet on Olive Avenue by 115 feet on Beresford Street which amounts to approximately two-thirds of the property under consideration. Mrs. Lynn understood that this is part of the "Long Range" planning for the Municipality of Burnaby but as this side of Beresford Street extends only from Patterson Avenue to Wilson Avenue, a distance of just over a block, she could not understand the reasoning behind this proposition, particularly as to take 32 feet off the adjacent properties on Beresford Street would destroy existing properties, including apartments which are comparatively new.

Mrs. Lynn was of the opinion that the required dedication of this portion of her property to the municipality would make it impossible to sell the property to interested private purchasers.

Mrs. Lynn was of the opinion that if the municipality needs her property Council could afford her the courtesy of affecting a settlement by purchase. If the municipality finds that they do not need the property, the least they can do is to remove this 'dedication clause" to enable her to sell to other interested parties.

The Administrator pointed out that under the agreement reached a number of years ago between the Chairman of the Greater Vancouver Regional District and the Minister of Health, capital costs for parking facilities would be shared between these two agencies provided that the Regional District owned and operated a parking facility on a pay basis which would amortize the capital cost over a reasonable period of time. The parking lot therefore is owned and operated by the Greater Vancouver Regional District on a pay basis. With regard to rates charged for parking, these are identical to those charged at

the Royal Columbian Hospital where the parking facility is also owned and operated by the Greater Vancouver Regional District. Mr. Barth also reported that directional signs both on and around the hospital property are being reviewed so that visitors to the hospital will have adequate direction to the parking facility.

In particular, the correspondents were alarmed over the plan to include the new library/recreation complex north of Cameron Street.

ENQUIRIES

Alderman Emmott

Alderman Emmott enquired if the Municipal Manager would be reporting to Council on the adequacy of current inspection and licence fees prior to Council's consideration of the 1979 Annual Budget.

The Municipal Manager replied in the affirmative and advised that this matter was already in hand.

Alderman Gunn

Alderman Gunn noted that Council was in possession of a letter this evening addressed to Mr. David Swityk from the Director of Administration of the Liquor Control and Licensing Branch advising that Mr. Swityk's request for preclearance of application for a neighbourhood public house licence to be located at the Parkcrest Shopping Centre had been refused by the General Manager on the grounds that the Liquor Control and Licensing Branch is not approving applications for neighbourhood public house sites located in shopping centres.

Alderman Gunn noted that it is his understanding that an application for a neighbourhood pub at this location had been refused two to three years ago and requested information as to why it took the Liquor Control and Licensing Branch so long to advise the applicants.

The Director of Planning advised that it was possible that Mr. Swityk had submitted a new request for preclearance of an application for a neighbourhood public house licence at this location without the knowledge of the municipality and that the letter from the Liquor Control and Licensing Branch was in reply to this latest request.

Alderman Drummond

Alderman Drummond noted that Bill 19, "British Columbia Urban Transit Authority Act" could have devastating repercussions on the municipality. Due to the importance of this subject, Alderman Drummond suggested that staff be instructed to prepare a report on this subject for consideration by Council at the next Council meeting.

In summary, the Municipal Treasurer reported that the by-law makes it the specific duty of every owner or occupier of a dwelling or a commercial or industrial premises to at least once in every seven days cause to be removed all refuse, landscape refuse and construction and demolition refuse. This means that if the occupier fails to do so, the responsibility rests with the owner.

The Municipal Act makes an owner responsible for the payment of refuse and a host of other charges if they remain unpaid by December 31 in the year in which the charges are due and payable whether or not the charges were incurred by a tenant or by the owner himself.

The Municipal Manager recommended:
