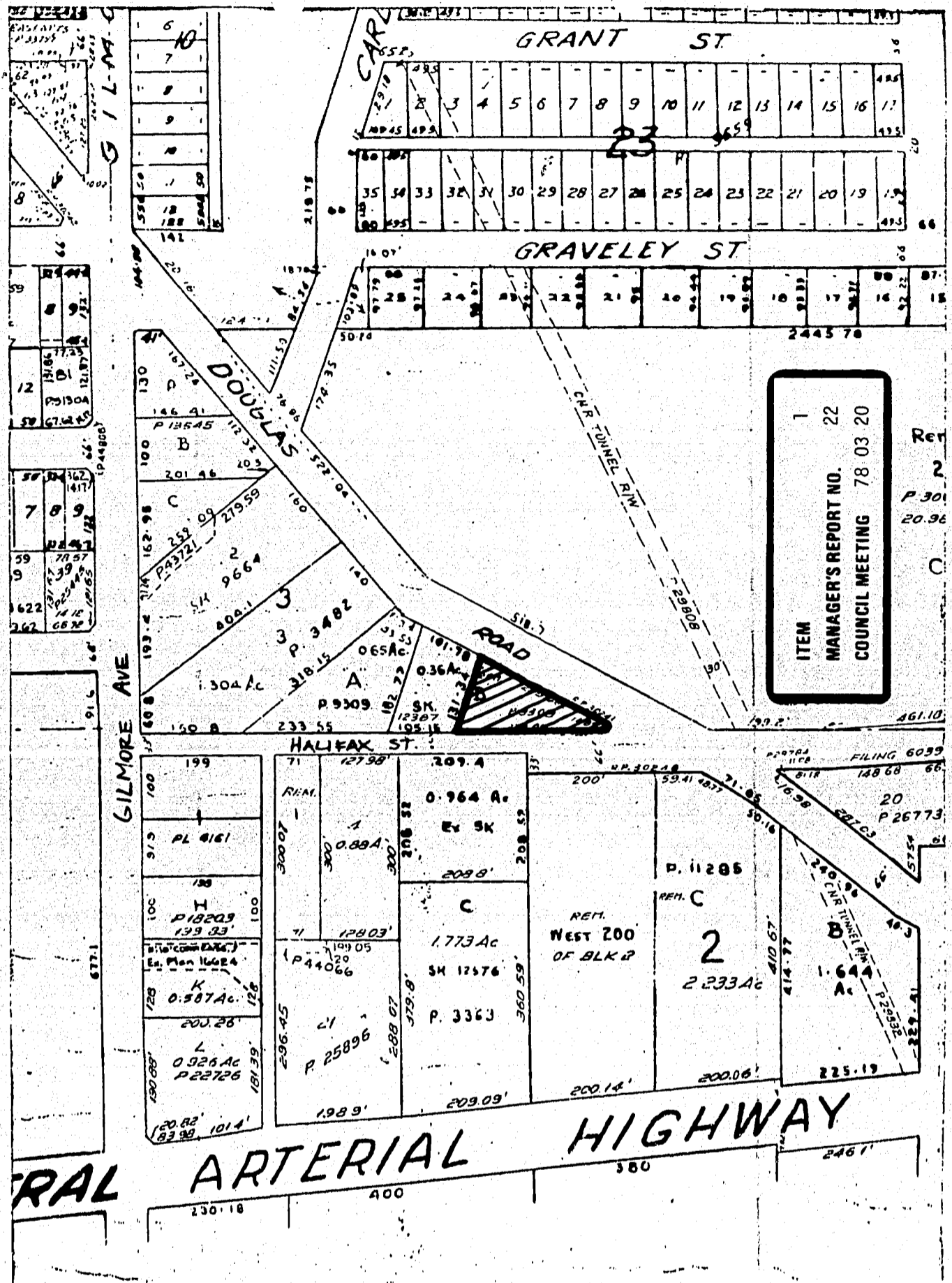
1.0 INTRODUCTION:

Appearing on the 1978 February 20 Council Agenda was a letter from a Mr. Doug Brice of the Fraternal Order of Eagles who has requested Council's endorsement of a Class "A" liquor license for their lodge at the above referenced location (see attached Sketch).

2.0 GENERAL COMMENTS:

2.1 Pursuant to the Provincial Liquor Act, the General Manager of the Liquor Control and Licensing Branch in consideration and approval of all liquor license applications may at his discretion require any of the various prescribed means (as outlined in the Act) for determining the views of the residents affected by the proposed licensed establishments. For this application, the General Manager requires that the application receive the prior approval of the Municipal Council by resolution.

2.2 The applicant has requested a Class "A" liquor license which may be issued to hotels, resorts, clubs, recreational centres, aircraft, trains, motor vessels, international airports, Municipal and Provincially owned cultural centres, universities and military messes. The subject facility would be regarded as "club" as defined in the 1965 Burnaby Zoning By-Law. Hours of liquor sale may be any 14 hours between 09:00 h and 02:00 h. In addition, certain of these Class "A" establishments may have off-premises sale of beer and B. C. cider where so endorsed by the General Manager. The site is presently zoned C4 Service Commercial which includes clubs as a permitted use.
