A letter dated 1978 October 27 was received advising that the need for a grade separation which would eliminate the existing heavily travelled crossing at grade of Sperling Avenue and which would provide freer north-south flow of traffic over the Burlington Northern Railway has been well documented in the last several years. It is expected, that when the district completes its studies, a new or revised application will be submitted to the Railway Transport Committee. The Committee's staff will give this very prompt attention.

The Municipal Engineering staff have, in the past, had discussions with the Regional Office in Vancouver. The Regional Office stands ready to give every assistance possible to the district in the preparation of the new application.

- d) Petition From 7200 And 7300 Blocks Pandora Street
Re: Asking That Either The Name Or The Numbers
On Pandora Drive Be Changed

A petition dated 1978 November 09 was received requesting that consideration be given to changing the name of the street or house numbers on Pandora Drive.

The petitioners pointed out that the naming of Pandora Street and the new Pandora Drive, both leading off each other in the new subdivision in the Westridge area, together with the fact that both streets have similar house numbers, is causing confusion and concern to the residents of this area.

As several of the houses on either street have, or will have, the same numbers, the residents are constantly being harassed by confused Mailmen, delivery boys and truckers. It will take little imagination to understand this situation.

3. Fallout over North Burnaby

The Municipal Manager provided a report from the Chief Public Health Inspector concerning a fallout which was apparently associated with operations at the Chevron Refinery.

The Chief Public Health Inspector provided a report from the Pollution Control Department of the Greater Vancouver Regional District regarding the fallout of the catalyst from the Chevron Refinery. The following is the substance of that letter:

"Some localized fallout of catalyst was evident in early October as a result of a breakdown in the F.C.C. Unit at Chevron. Chevron notified the Regional District when the breakdown occurred and subsequently shut down the unit to carry out the necessary repairs.

The application for the existing Chevron Air Pollution Control Permit was reviewed by the Provincial Ministry of Health to determine the acceptability of the proposed discharges from the health stand point. The effect of catalyst is also considered in this review. They concluded that no problems were anticipated with the permitted levels of emission."
