The attached letter, dated 1978 09 18, has been received by the Mayor requesting the Municipality of Burnaby to bid to host the 1980 or 1981 British Columbia Games.

Staff is of the opinion that 1983 would be a logical time to host both the British Columbia Summer and Winter Games as a ten year anniversary of the hosting of the 1973 Canada Summer Games. The Games could be hosted jointly with the City of New Westminster.

With the concurrence of the Commission, staff would be prepared to meet with staff of New Westminster Parks and Recreation Department to discuss the ramifications of such a proposal. Following this discussion, a report would be sent to the Commission with a recommendation to be forwarded to Council.

On behalf of the Government of British Columbia, it is my pleasure to invite the District Municipality of Burnaby to bid to host the 1980 or 1981 British Columbia Games. Your community may bid on all or any one of the 3 above-mentioned Games, however, the Games will be awarded to 3 different communities. In other words, you may send in 3 bids but you could only be successful on one.

The first ever British Columbia Summer Games were held in Penticton, August 17 to 20, with the response and success of the Games clearly outstanding. Three thousand athletes competed in Penticton with about 39,000 athletes participating in the zone playdowns. Undoubtedly, you witnessed part of the television coverage from Penticton and now know more about the extent of the Games. The 1979 British Columbia Winter Games will be held in Kamloops and the 1979 British Columbia Summer Games have been awarded to Richmond. Estimates show that between 90-100,000 British Columbians will become involved during the course of a year with the Games.

You will note in the enclosed guidelines that the Government of British Columbia will provide \$190,000.00 for the administration and operation of the Games. The 1980 British Columbia Winter Games are to be held in March 1980. The 1980 British Columbia Summer Games are to be held in August 1980. The 1981 British Columbia Winter Games are to be held in March 1981.
