CARRIED UNANIMOUSLY

a) Mrs. Charlotte Rozman then addressed Council on the subject of the rezoning or subdivision of her property at 6483 Trapp Avenue.

The following is the text of Mrs. Rozman's submission:

"We are not here for an argument or just to pass the time or to pester you. On the contrary, we have our hands full of trouble. It is a matter of existence, survival, to be or not to be. We have put money to acquire and would like to get an equivalent amount out when we sell but we cannot sell at all and that should indicate that the property is overtaxed. We are not complaining of that and are willing to share in the tax burden. If we could pick up those 20,000 square feet of land and transfer it to Langley or Mission or Chilliwack there would be more chance of development. Here is a parcel of a land in the centre of the metropolitan area of Greater Vancouver. We already have streets and services but we are told over and over again that it needs a Community Plan that will take maybe years to decide upon. This is an old developed area and needs improvements and upgrading badly. Under present circumstances our property is worthless and in limbo because nothing can be built on it. If we cannot even sell for the allowed devaluation price it must be overtaxed. Even the fire insurance was cancelled because of the deteriorating neighbourhood. Further you write in your Manager's Report of August 1974 and I quote: 'Mrs. Rozman's proposed subdivision of Lot $11S^{1}_{2}$ into two R5 lots makes the rezoning precedent more difficult to resist because the economic gain to the property owner of both rezoning and subdivision are major. Almost every property in the designated A2 area would have potential for rezoning if RZ#29/74 was successful.' This surprises us and it sounds as though we intend to do something unlawful and must be prevented under all circumstances. In truth, we have no intention to do something that was not in accordance with the law in general and with the by-law of Burnaby in particular. We had inquired and got support from most of the Aldermen and the Engineering Department on the Burnaby and New Westminster sides. It appears to us more a breach of trust against the people who have voted for you and put you all into office. Is there no pledge to work for the interest of the people and not against? Stalin was notorious for his cruelty but even he was said not to have taken the last cow out of the barn. We suspect that there must be something rotten in the state of Denmark. We have been waiting patiently for many years and we must sell now. We are asking for a sensible decision for one of the various possibilities suggested in our letter of February 14, 1978."

The following are the suggestions put forward by Mrs. Rozman in her letter dated 1978, February 14:

- 1. Annex to New Westminster if services cannot be provided.
- 2. Sewer hook-up to New Westminster for two single or duplex dwellings.
- 3. Vacuum Sewerage System to be installed by Vacusan Systems Ltd. or Marketing Manager Mr. J.W. Archer at an approximate cost of \$ 6950.00 including drainfield and septic tank. This is considered economical for two or more homes, one would cost about the same.
- 4. M3 Zoning already on other side of Trapp Road. No new houses built in last 10 or 20 years. Deteriorating neighbourhood.

Mrs. Rozman stated that definite action and decision would be very much appreciated because she has already been waiting almost four years.

It was agreed that the report regarding the hook up of Mrs. Rozman's property to the New Westminster Sewer System received by Council approx-imately 18 months ago would be distributed to Council members for their information during the coming week.

MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN RANDALL:

"THAT Item 15, Municipal Manager's Report No. 16, 1978, February 27 be brought forward for consideration at this time."

CARRIED UNANIMOUSLY

The Municipal Manager reported that in the opinion of staff rezoning or subdivision of the property at 6483 Trapp Avenue should not be considered. However, if Council should decide to permit density in the area to increase, we should then prepare a proposal related to the eventual construction of a conventional sanitary sewer to service the properties in the area in question.

MOVED BY ALDERMAN RANDALL: SECONDED BY ALDERMAN DRUMMOND:

"THAT the report of the Municipal Manager be received for information purposes."

CARRIED UNANIMOUSLY

b) Mr. Dennis Alexander then addressed Council and presented a petition signed by 407 residents of the Lakeview Neighbourhood Area indicating support for the action proposed by the Traffic Safety Committee to alleviate the traffic problems presently existing in this area.

The following is the preamble to the petition received:

"In consideration of a Planning Department report dated 1978 February 13 concerning the Edmonds - Sixth Street area study, your Traffic and Safety Committee adopted recommendations to institute the following:

- 1. An A.M. peak period stopping prohibition on the north side of Edmonds Street from 6th Street to Canada Way.
- An additional travel lane on the north side of Edmonds Street from 6th Street to Canada Way.
- A request for rigid R.C.M.P. speed limit enforcement in the Lakeview Neighbourhood Area on a frequent basis for a minimum 6 month period.
- 4. A cul-de-sac on Wedgewood Street in the vicinity of 7773 Wedgewood Street on agreement from the commercial and residential property owners currently having a driveway connection to Wedgewood Street.
- 5. A one-way street system arrangement allowing vehicular traffic on 6th Street between Wedgewood and Edmonds Streets to move in a southbound direction only (toward New Westminster only).
- 6. A comprehensive Engineering evaluation of the effects of these changes on the traffic conditions in the Lakeview Neighbourhood Area after 3 months of operation.

In addition to these recommendations, your Committee decided not to consider stop sign control at this time.

We the undersigned residents of the Lakeview Neighbourhood Area hereby support the recommendations as numbered 1 through 6 above. We are, however, concerned that, while these changes are a positive step in the right direction, stop sign controls will still be necessary should the safety of the residential street intersections within our area not show a marked improvement. We, therefore, request that the Engineering evaluation of the effects of these changes include a critical examination of the safety of the individual intersections.

In addition, we wish to re-emphasize the importance of concurrently implementing the planned cul-de-sac or blockade of Mayfield Street at Canada Way to maximize the safety of the many children attending Lakeview Elementary School."

Mr. Alexander went on to say that he and the petitioners were particularly concerned with Recommendation No. 4 in the report of the Traffic Safety Committee which recommended that "stop" signs not be considered for installation on municipal streets as speed control devices. Mr. Alexander stated that in the opinion of the petitioners the use of stop signs in this particular instance was not primarily a method of speed control but would be used to provide greater safety to pedestrian and vehicular traffic in the area. The use of stop signs as previously suggested by the petitioners could only assist in the reduction of the accident frequency along Sixth Street at the intersections under consideration. Mr. Alexander was also concerned that it did not appear that consideration had been given to advancing the construction of a cul-de-sac on Mayfield Street at Canada Way as recommended by the petitioners. It was considered that the construction of this cul-de-sac was a necessity to ensure added safety for school children attending Lakeview School.

MOVED BY ALDERMAN GUNN: SECONDED BY ALDERMAN RANDALL:

"THAT Item 1 of the report of the Traffic Safety Committee pertaining to this subject be brought forward for consideration at this time."

CARRIED UNANIMOUSLY

The following are the recommendations contained in this report:

- THAT parking and stopping be prevented on the north side of Edmonds Street from Sixth Street to Canada Way during the morning peak traffic flow.
- 2. THAT an additional travel lane be established on the north side of Edmonds Street commencing at Sixth Street and continuing to Canada Way to accommodate commuter traffic.
- 3. THAT the commercial and residential property owners currently having an approved or recognized driveway connection to Wedgewood Street confirm to Council their agreement to the development of a cul-de-sac on Wedgewood Street, preferably in the vicinity of 7773 Wedgewood Street.
- 4. THAT "Stop" signs not be considered for installation on Municipal Streets as speed control devices.
- 5. THAT Sixth Street be designated a one-way street for southbound vehicles only from Wedgewood Street to Edmonds Street by the placement of a one-way only and Do Not Enter signs on Edmonds Street at Sixth Street.
- 6. THAT the Royal Canadian Mounted Police be requested to rigidly enforce the speed limits in this residential neighbourhood on a sporadic but frequent basis for at least a 6 month period as a means of discouraging speeders from daily using residential streets as alternative "Short-cut" routes to the arterial street
- 7. THAT subsequent to implementation of Recommendations 1,2 and 5, the Engineering Department again monitor, by means of a licence plate survey, the traffic entering and leaving the area to determine whether there has been any significant change in commuter travel patterns and that a further report be submitted to the Traffic Safety Committee in 3 months time.

MOVED BY ALDERMAN EMMOTT: SECONDED BY ALDERMAN DRUMMOND:

"THAT Recommendations 1,2,3,5,6, and 7 of the Traffic Safety Committee aforementioned be adopted."

The meeting concurred with a suggestion by the Mover and Seconder of the foregoing motion that Recommendation No. 7 of the Traffic Safety Committee be amended to read as follows:

"A comprehensive engineering evaluation of the effects of these changes on the traffic conditions in the Lakeview Neighbourhood Area be conducted after the proposed changes have been in operation for three months including a monitoring, by means of a licence plate survey, the traffic entering and leaving the area to determine whether there has been any significant change in commuter travel patterns."

His Worship, Mayor Constable welcomed members of the Burnaby Mountain No. 55 Girl Guides to the Council Meeting this evening and expressed the wish that the meeting would be both informative and interesting.

The Engineering Department is reviewing this specific matter and will provide the Committee with whatever information may be required for its deliberations. Any subsequent reports to Council would be submitted by the Committee in accordance with established procedures.

A letter dated 1978 February 09 was received enclosing twelve copies of the low cost spay and neuter clinic report - second report covering the period 09 August to 08 August, 1977.

c) City of Vancouver, Deputy City Clerk, RE: Greater Vancouver Regional District Matters: Light Rapid Transit Studies.

A letter dated 1978 February 16 was received advising that Vancouver City Council at its meeting on 1978 February 14 had adopted a motion indicating that the City Council welcomed the Greater Vancouver Regional District support for an immediate start on an analysis of the first priority transit routes.

MOVED BY ALDERMAN GUNN: SECONDED BY ALDERMAN DRUMMOND:

"THAT:

- Burnaby Municipal Council welcomes the Greater Vancouver Regional District's support for an immediate start on an analysis of the first priority transit routes.
- 2. Burnaby Municipal Council appreciates the necessity of close cooperation with the Province and would favour the Greater Vancouver Regional District's proposal that the Province of British Columbia share one-half of the costs of the study. However, if the Province of British Columbia prefers to co-operate in another arrangement, the proposal would be modified accordingly.
- 3. The discussions with the Province of British Columbia concerning their participation be undertaken by the Greater Vancouver Regional District Transportation Committee.
- 4. Burnaby Municipal Council suggests a time limit of two to three months to deal with objectives (1) and (2) of the Greater Vancouver Regional District which are:
 - a) To determine the type of high capacity rapid transit is best for corridors between Surrey-Downtown Vancouver-Richmond and New Westminster-North East Sector.
 - b) To decide upon the priority for high capacity rapid transit routes, based on ridership potential, cost and service standards.
- Burnaby Municipal Council would make available Municipal staff to work with the consultants on such a study.

- 6. Burnaby Municipal Council recommends to the Greater Vancouver Regional District that the technical committee be kept small and be limited to the parties technically involved in the first priority route.
- Burnaby Municipal Council questions the value of setting up a special political 'Review Committee'.
- Copies of this motion be sent to the City of Vancouver, the Greater Vancouver Regional District and the Minister of Municipal Affairs and Housing."

ENQUIRIES

Alderman Gunn

Alderman Gunn noted that on Sunday morning, 1978 February 26 he had detected a strong sulphur smell coming down Burrard Inlet. Alderman Gunn requested that staff find out where the smell came from and what is currently happening at the B.C. Hydro Thermal Generating plant at Port Moody and the oil refineries in North Burnaby.

Alderman Gunn further requested that a report be submitted on the current air quality monitoring system in the Eastern Burrard Inlet area.

Alderman Gunn indicated that he would appreciate receiving a status report on the current air monitoring program in that area.

Alderman Emmott stated that the Greater Vancouver Regional District would be holding several Committee meetings this coming Wednesday and that this subject could be covered at that time.

Alderman Drummond

Alderman Drummond noted that the Mayor had previously stated that there was an air monitoring station at Ioco and requested information on how long this air monitoring station had been established at this point.

His Worship, Mayor Constable indicated that he would provide Alderman Drummond with this information.

Alderman Randall

Alderman Randall enquired as to whether in the opinion of the Municipal Engineer, municipal by-laws governing street cleaning, filling of land, etc. were capable of adequate enforcement. Alderman Randall stated that he had had several complaints of streets being cluttered up by dirt from new construction, etc. and it did not appear that enforcement of existing by-laws was being followed.

The Municipal Engineer advised that this problem was not a matter of by-law enforcement as much as the inability of his department to keep abreast of the many developments being placed in the Municipality. Immediate corrective action is taken by the Engineering Department when a particular situation becomes known.
