RECOMMENDATIONS

- 1. THAT Council approve the Burnaby Mountain Golf Course relocation of the Pro Shop as recommended by the Commission in their report of 1978 November 15; and
- 2. THAT Council direct that this project be financed by an appropriation of \$50,000 from C.I.P. contingency.

REPORT

Through a misunderstanding between the Parks and Recreation Administrator and myself, the financing of the proposed relocation of the Burnaby Mountain Golf Course Pro Shop was shown in the above report as borrowing. The recommendation should have been that Council approve the project and direct that it be financed by an allocation of \$50,000 from C.I.P. contingency. The problem here is that unless the item appears in the C.I.P., neither Council nor the Commission have the authority to proceed. Furthermore, as funds are available there should be no need to borrow them.
