The Institute for Administrative Management (a specialized "division" of A.P.W.A.) will conduct a program on Zero-Base Budgeting, another worthwhile subject.

The Engineer has acted as Local Coordinator for two very successful workshops sponsored by A.P.W.A. in this area; he has also assisted the Municipal Manager in guiding the Public Works Association of B.C. into becoming a Chapter of the American Public Works Assocation, which is probably now only about 3 weeks away from coming about.
