Once again the subject lease is up for renewal (see copy of letter <u>attached</u>).

The subject property was originally leased to No. 637 Squadron from 1969 December 01 to 1975 June 30. Council renewed this lease on a one year term on 1975 July 01 to 1976 June 30 and again from 1976 July 01 to 1977 June 30. From 1977 July 01 to 1978 June 30, the lease was renewed on a month to month basis with no formal document.

The taxes for 1975 were paid by Municipal grant and the 1976/77 assessments were given tax exemption. The assessed values for 1978 are:

Planning department has no objections to the lease and as considerable time is involved drawing documents and submitting reports, the Lands department would recommend as follows.
