The subject houses have been advertised for sale through public tendering. The tendering has now been completed and this report recommends actions to be taken as a result of completion of tendering.

A. 7793 GRAHAM AVENUE


The Parks and Recreation Commission at its meeting of 1978 April 05 concurred with the Director of Planning's recommendations

- "1. THAT Council authorize the Purchasing Agent to call for tenders for the sale of the house at 7793 Graham Avenue on the condition that the house be removed from the site within 30 days.
- 2. THAT Council authorize the Land Agent to have the house demolished if acceptable tenders for the relocation of the house are not received."

Council, on 1978 April 10, approved the recommendations. Since that time, an advertisement was placed in the <u>Vancouver Sun</u> on April 28 and 29 requesting bids. This advertisement is <u>attached</u> in Appendix I. Only one bid to purchase was received offering \$136.00. The Land Agent, in his memo of 1978 May 24 (<u>attached</u>)

recommends accepting this bid. The Planning Department would concur with the Land Agent's recommendation.

B. <u>7418/7422/7428/7434</u> VISTA CRESCENT

The Parks and Recreation Commission at its meeting of 1978 February 01 approved the recommendation

"THAT the Commission request the Municipal Manager to instruct the Land Agent to obtain the necessary approvals from the Building Department, and to proceed with offering for resale the houses identified in this report."

Since that time the necessary approvals have been made and the houses have been advertised for sale in the Vancouver Sun on April 28 and 29 (see Appendix II). The bids which have been received on these four properties are outlined in the Land Agent's memo of 1978 May 24. The Land Agent recommends that Bid Numbers 5 and 6 submitted by T. and M. Galitzky in the amounts of \$5110.50 for 7428 Vista Crescent and \$4110.50 for 7434 Vista Crescent be accepted, and that Bid Number 4 submitted by G.H. Smith in the amount of \$766.00 for 7422 Vista Crescent and \$266.00 for 7418 Vista Crescent be accepted. The Planning Department concurs with the Land Agent's recommendations.

The Land Agent further suggests that since the Municipality has reserved the right to reject any or all tenders, that should any of these transactions not be consummated, the next succeeding high bidder be contacted with a view towards selling any buildings on which the bidder does not perform.

Net revenues from these house sales (proceeds remaining after costs are paid) will be placed in the Municipal Tax Sale Fund to await preparation of a by-law which will return the funds to the appropriate N.I.P. or Park Levy budget.

RECOMMENDATION

It is therefore recommended:

- 1. THAT Council approve the Land Agent's recommendation to accept the high bids for each of the subject properties, as outlined in this report; and
- 2. THAT should any of these transactions not be consummated, the next succeeding bidder be contacted with a view towards selling any buildings on which the bidder does not perform.


