The Municipal Manager reported that Item 18 on Page 164 from the Parks and Recreation Administrator and Item 19 on Page 198 from the Director of Planning in this evenings agenda contains considerable background information on the proposed expansion of Heritage Village. From the Municipal Manager's point of view, if we proceed with the construction of the underpass as planned, and allowance of 20 feet for the development of the trail link would be inadequate and weishould, on this basis, adopt the Director of Planning's recommendation. Although the Manager has personally not examined the technical ramifications of the proposal thoroughly, and is therefore not absolutely certain that we will need all of the area as noted on Sketch 2, he is satisfied that more than a 20 foot portion will be required. In any event, little is to be gained from a delaying action with respect to Lot 5 in view of the fact that a viable linear park system has received considerable support from all concerned, and a number of major decisions have already been made to ensure that it becomes a reality.

The Municipal Manager recommended:

- 1. THAT the Green House remain part of the Burnaby Arts Centre.
- 2. THAT the width of the trail corridor abutting Lot 7 be 160 feet with an approximate 100 foot portion of the corridor to be developed as outlined in this report.
- 3. THAT the property between Dale Avenue and Sperling Avenue not be included within the boundaries of Heritage Village.
- 4. THAT the north-south trail link from Deer Lake to Canada Way be along Dale Avenue.
- 5. THAT the portion of Lot 5 lying east of Deer Lake Brook including the stream itself and a 10 foot to 12 foot strip for screening the future fence be retained as part of the Public Park outside the boundaries of Heritage Village.
- 6. THAT a copy of this report be forwarded to the Parks and Recreation Commission and the Century Park Museum Association.

MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN MERCIER:

"THAT Recommendations Nos. 1, 2, 3, 4 and 6 of the Municipal Manager, aforementioned, be adopted and that Recommendation No. 5, aforementioned, be amended to read as follows:

THAT the future boundary of Heritage Village on the north and east sides be to Dale Avenue and further, that the staff examine and report to Council on an alternate location for the trail crossing and the type of crossing to be located between Dale Avenue and Sperling Avenue."

MOVED BY ALDERMAN LAWSON: SECONDED BY ALDERMAN DRUMMOND:

"THAT further consideration of this matter be tabled."

The votes being equal FOR and AGAINST the Question, the Question was declared negatived and LOST.

A vote was then taken on the original Motion as MOVED by Alderman Ast and SECONDED by Alderman Mercier "THAT the recommendations of the the Municipal Manager be adopted", as amended, and same was CARRIED with Aldermen Drummond, Gunn and Lawson OPPOSED.

18. Heritage Village Expansion

The Municipal Manager provided a report from the Parks and Recreation Administrator regarding the proposed expansion of Heritage Village. The Municipal Manager noted that the recommendations that he is advancing for the consideration of Council are contained in Item 17 of his Report No. 76, 1978 October 30.

MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN DRUMMOND:

"THAT the report of the Municipal Manager be received for information purposes."

19. Heritage Village Expansion

The Municipal Manager provided a report from the Director of Planning regarding the proposed expansion of Heritage Village.

The Municipal Manager noted that the recommendations that he is advancing for the consideration of Council are included in Item 17 of his Report No. 76, 1978 October 30.

MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN RANDALL:

"THAT the report of the Municipal Manager be received for information purposes."

20. Youth Services Division

The Municipal Manager noted that in Item 11, Municipal Manager's Report No. 8, 1978 January 30, he had advised that the Ministry of the Attorney-General had expressed an interest in providing funds for the Youth Services Division subject to the condition that the funding would be made over a three year period if the Municipality thereafter carries "the programme forward".

We are still waiting a response from the Ministry, but we have recently been asked to supply a letter of support from the School Board in Burnaby for the reactivation of the Youth Services Division. This letter has been written, and it is the Municipal Manager's understanding that we may hear something from the Province within the next two weeks. We feel optimistic about the outcome of our application for funding.

The whole matter was the subject of discussion between the Police Chiefs of the Lower Mainland and representatives from the Attorney-General's Office on 1978 October 12, so the matter does seem to be coming to a head.

MOVED BY ALDERMAN RANDALL: SECONDED BY ALDERMAN GUNN:

"THAT the report of the Municipal Manager be received for information purposes."

21. 1978 Recast/1979 Provisional Budget

The Municipal Manager provided copies of the 1978 Recast Budget and 1979 Provisional Budget.

The Municipal Manager noted that specific recommendations have been included in the letter of transmittal.

The Municipal Manager recommended:

- 1. THAT the Recast Budget be received, approved, and the necessary Budget Amending By-law be brought forward.
- 2. THAT the 1979 Provisional Budget be received, considered by the Municipal Council as a working document at the three special meetings planned in November, and referred to the 1979 Council for its consideration.
- 3. THAT the Municipal Manager continue his review of the Provisional Budget and bring forward a further report on it once the Provincial Revenue Sharing Grants are known.

MOVED BY ALDERMAN GUNN: SECONDED BY ALDERMAN RANDALL:

"THAT the recommendations of the Municipal Manager be adopted."

22. Distribution of the Transportation Policy Review Brochure

The Municipal Manager provided a report from the Director of Planning regarding a problem involving the distribution of the Transportation Policy Review Brochure.

The Director of Planning reported that as a result of the recent postal disruptions, the Municipality retained United Flyers Distributors Limited of 3115 Underhill Avenue to distribute the above captioned brochure to every household and business in the Municipality. This distribution was undertaken on a pre-payment basis on 1978 October 20, 21 and 23 at a cost of \$2,091.04. During the latter part of last week the Planning Department undertook a survey to determine the success of the distribution undertaken by United Flyers. On the basis of approximately 67 responses received, it was determined that roughly 40 percent of those contacted were aware of receiving the brochure. As a result of the widening of the survey, it would now appear that it is most likely that well over 50 percent of the persons contacted did not receive a brochure.

The Municipal Solicitor has been asked to report on whether it is worth while attempting to recover all or part of the printing and distribution cost incurred by the Municipality from United Flyers Distributors Limited.

The Municipal Manager recommended:

- 1. THAT this report be forwarded to the Burnaby Transportation Committee
- 2. THAT an additional newspaper notice be placed extending the public submission deadline to 1978 November 17 as well as once more advising residents of the availability of the brochure.

MOVED BY ALDERMAN GUNN: SECONDED BY ALDERMAN DRUMMOND:

"THAT Council direct the Transportation Committee to print up another batch of the 'Transportation Policy Review' brochures with the ensuing distribution to be done through the post office and that the brochures be accompanied by a letter explaining what happened to the original distribution and setting a new date by which submissions from interested citizens are to be received."
