INAUGURAL ADDRESS

His Worship, Mayor Constable, then delivered his inaugural address: The following is the text of His Worship's address:

"It is my pleasure to welcome you to the Inaugural Meeting of the 1979 Burnaby Municipal Council.

Our congratulations to the newly-elected School Board Trustees Joanne Beamish, Elsie Dean, Barry Jones, "Doc" Street and June Williams. I am sure that we can rest assured that they will work together to fulfill the educational needs of the students of Burnaby. Our thanks also to all who offered their services as candidates. Without the possibility of choice, democracy would suffer. Our thanks also to the many dedicated people who serve on our various Boards, Commissions and Committees - they give of their time unstintingly and I want them to know that members of Council are very appreciative of their efforts for their community. In particular, Mr. Arthur Lock has served six years on the Parks and Recreation Commission and is therefore no longer eligible for re-appointment. Art has served as the Chairman of the Parks and Recreation Commission and has been involved in many decisions to create excellent policies and programs. Art's quiet, but determined, manner will be sadly missed on the Parks and Recreation Commission. I am sure, however, that he will find other things of interest to do on behalf of the community. Mr. Gerry Houlden has also

completed his third two-year term on the Library Board and is not eligible for re-appointment. Gerry has seen some very interesting and innovative programs initiated in our Library system and his abilities and expertise will certainly be missed. Hans Krause has served on the Advisory Planning Commission for two three-year terms and is not eligible at this time for re-appointment. has served on the Advisory Planning Commission during the periods of time when Council were asking them to make recommendations on some very important issues affecting the future of our Municipality. He will, in the future, see changes taking place with the knowledge that he participated in the decision-making. Although we do not hear too much of the Burnaby Board of Variance, we do, of course, have Council appointed representatives on the Board who, along with others, hear the appeals with reference to zoning matters. Mrs. Hellier has served six years on the Family Court Committee and is not eligible for reappointment. The Family Court Committee also serves as the Justice Council and are serving an important function in the Municipality. To all these people, on behalf of Council, I express our deepest appreciation and all will be receiving a Certificate of Appreciation as approved by Council this year.

The year 1978 has been a relatively quiet year, with no great earth-shaking issues on the scene. It has, nevertheless, been a pleasure for me to work with Council members who have been extremely co-operative and we have all worked very well together during the year and I am pleased to say have not played a game of partisan politics, Municipal - that is; instead, have worked in what we see as the interests of the citizens of Burnaby.

As a result of illness I was off for several months and I want to sincerely thank members of Council for their messages of support during that time. My personal and particular thanks go to those members of Council who shouldered the extra burden in the capacity of Acting Mayor. I am very pleased to say that I am now in excellent shape and, in fact, most days I manage to get in a brisk 5 mile walk.

At this particular time I would also like to thank the great number of people who gave their best wishes for a speedy recovery during my illness.

While expressing our thanks to so many people, I would be negligent if I didn't make some mention of thanks to the regular attenders to Council meetings - those representatives of community associations who attend regularly and who monitor our activities so well.

In February 1978 Council gave approval in principle to the Metrotown concept. Eventually it will produce a well-designed urban development with the pedestrian orientation, public open spaces, and also will be related to future transit needs. This was and is a very important decision affecting the very future of Burnaby's autonomy and identification. We will, however, have to take great care in steering this project very carefully through the next few critical years.

Also, in 1978, we established the Transportation Committee whose activities will result hopefully in a recommendation to Council to adopt a comprehensive transportation policy for our Municipality. One of the major projects to be discussed by this Committee will be the proposed crossing of the Burlington Railway tracks. It is my personal hope that members of the Committee will treat this on a priority basis and bring their recommendation to Council as soon as possible. Two citizens were appointed to this Committee and I want to put on record our thanks to Mr. Ramsell and Mr. Tarling for their participation. A Brochure entitled "Towards a Comprehensive Transportation Policy for Burnaby" was distributed to every household and business in Burnaby (some received two). Meetings will soon be held to receive maximum imput from our citizens on this very important issue. Along with other public participation programs in Burnaby we can, with pride, claim leadership in keeping the people of Burnaby well informed and participating.

1978 also saw a special Citizens' Committee recommend to Public Works Minister Alex Fraser, that 175 acres of the Oakalla lands be turned over to the District of Burnaby for park use. In recent correspondence the Minister of Highways and Public Works has assured me that he intends to bring this matter to a conclusion as soon as it is possible. I will be meeting with him in the very near future.

In 1978, Burnaby saw a drop in total value of construction permits compared to the three previous years. However, there was a general overall regional slowdown in market growth, but comparing with other Lower Mainland municipalities, indications are that Burnaby, in 1978, did quite well.

Over the last four or five years, Burnaby Council has shown great fiscal responsibility in keeping tax increases to a minimum. In 1978 Burnaby Council showed that continuous fiscal responsibility in adopting the low increase budget for this year. Information prepared by the Union of B.C. Municipalities gives comparative levels of property taxes which were levied by B.C. Municipalities in 1978, compared to those levied in 1977. The levels were based on reports from 139 municipalities out of a total of 140. This information shows that property taxes for general and municipal purposes increased by an average of 7.6 percent. For Burnaby, using the same criteria, the increase was only 2.56 percent. As a further comparison to municipalities quite close, Vancouver increased 4.5 percent; West Vancouver 5.4 percent; and Surrey 4.8 percent. For 1978 we were also faced with amendments to the Assessment Act. According to government authorities the purpose of the new Assessment system was to equalize property values; however, this would have meant a very heavy burden on business and to ease this burden, Burnaby Council chose to remove the business tax. From all indications this was a wise move and is showing to be of benefit to the Municipality.

Facing us in 1979 is an even greater challenge. In June 1978, the people of California went to the polls to vote on a measure known as Proposition 13. This was approved by a vote of almost two to one. The resulting vote came about after a massive campaign to reduce taxes and limit the tax on property to one percent of market value.

Naturally, there was a carry-over of this so called tax revolt into Canada and particularly in B.C. but, so far, without the same measure of success. However, there is little doubt that the people of B.C. want to see moderation in government spending and that message comes over very clear. What was not clear in California was where people expected to see cuts made. The Los Angeles Times conducted a poll that showed 69 percent of the electorate wanted cuts in welfare to the poor; 21 percent thought cuts in mass transit could be made. Most striking and surprising of all was that 70 percent of those questioned did not believe that many cuts in service would actually be required.

What has become very apparent is that the circumstances in the two areas cannot really be compared. In comparison, taxes are much lighter in B.C. than California. In B.C. net property taxes on the average home are currently less than one percent compared to 2 to 3 percent in California.

Nevertheless, it will be the responsibility of this Council to make sure that every dollar that we spend is spent wisely and that services to the community are efficient. Tax increases must be kept to a minimum.

In my opinion, it is essential that as the elected representatives of Burnaby people we must encourage more industry into Burnaby to provide more employment and to broaden our tax base. The Big Bend area, in particular, must be made attractive to companies wishing to locate in Burnaby. The Minister of Highways, The Honourable Alex Fraser, has assured me that he will bring the question of Marine Way to a conclusion as soon as possible. This Council must make a decision on the need to upgrade Byrne Road as soon as possible to show good faith in our determination to see parts of the Big Bend Area developed. Proposals have been received for the development of parts of the 3800 - 3900 Blocks on Hastings Street. These proposals are currently being studied by our Planning Department and soon the Committee established by Council for this purpose will be looking at them and making recommendations to Council. We are all, I am sure, looking forward to seeing early development taking place in this area. Phase 2 of the Marathon development across from the Municipal Hall will be starting in the early part of the New Year. 1979 will also see a start to construction of two recreational and community developments - one in the North-East sector, and the other - a N.I.P. development in the East Burnaby area.

For some time now I have been receiving suggestions from citizens of Burnaby that there is a great need for a fairly large and central community and cultural centre. In discussions with representatives from service organizations and community associations, it is being suggested that we need a centre that would accommodate from one to two thousand people. Due to the economic

difficulties that all municipalities are currently facing it would not appear to be practical to start on anything of this nature in the very near future. However, it is my intention to recommend to Council the establishment of a Committee, whose Terms of Reference would be to (1) study the need for such a facility, and (2) if the need is proven, to select a suitable location, and (3) to determine, by discussion with community associations and service organizations, the best method of financing. I would see the work of this Committee being a lengthy and extensive process.

As already mentioned the 1978 activities of Council have been one of co-operation and not confrontation. We have had excellent guidance from our extremely competent staff and certainly I would not be diligent in my duties if I did not convey my personal thanks and the thanks of Council to them. For 1979, I see the activities of Council being somewhat the same. I look forward with eager anticipation to working in co-operation with members of Council in whatever the year may bring.

 b) Mr. Michal Kaburda then addressed Council on his concern in the manner in which Mayor T.W. Constable handled an enquiry submitted by Alderman G.D. Ast on 1978 September 25.

The following is the text of Mr. Kaburda's submission:

"My question of concern is the manner in which Your Worship has handled an enquiry submitted by Alderman Ast on September 25, 1978. This writer and a number of other Burnaby citizens were in attendance when Alderman Ast made a motion of enquiry directed to the Burnaby Detachment of the Royal Canadian Mounted Police to submit a report to the Council concerning numerous allegations that there is usually an associated crime increase around drinking establishments as compared to areas without drinking establishments.

We certainly recall the Alderman referring specifically to drinking establishments in general, yet, the minutes state that he was comported with a document which 'apparently alleges that a severe increase in a state all categories of crime may be expected in the neighbourhood if a public clowed'.

It seems that in typing of the minutes a literary licence was applied, when the words 'drinking establishments' were changed to 'a pub'. However, on considering the minutes as they have been adopted, we have noted that upon submitting a letter from your office to Sup't C.L. Thomas, again a poetic licence appears to have been evoked.

May we point out that Alderman Ast's motion did not refer to any rezoning application nor did the document in question identify any specific site or area in Burnaby.

Sir, when Your Worship attached the enquiry to the rezoning reference 12/78 application No. 3/78 your action, in our opinion, purposefully buried the police report. We do not consider Your Worship's action to have been carried out in a fair manner. To us it appears to have been a perfect death sentence of a valid community issue. We petition you now to withdraw your letter of enquiry as well as the reply from the legal umbrella of the rezoning regulations and to allow the public to debate the merits of the police report before the Council.

We petition you to give the concerned public an opportunity to respond to the police report. We do not consider the Inspectors report to be a complete reply to your letter. Furthermore, we did expect to find your letter of enquiry to be published in its entirety in the usual agenda. Again, someone edited the contents so as to prevent the Council and the public at large from perusal of the entire contents.

Furthermore, the circulating document mentions thirteen separate allegations. A copy of the document is submitted for the records. Only one allegation is covered by the Superintendent's reply. We therefore consider the report to be incomplete in that we feel that the Burnaby Detachment R.C.M.P. does have crime statistics. If one is to consider the pub issue, the following areas can provide us some information and statistics in crime before and after establishments of the neighbourhood public houses at 6104 S.E. Marine Drive, 'The Waterhole No. 3' and 5665 Kingsway, 'Delany's Place'. They can also compare the crime activity within the half mile radius surrounding 4561 Kingsway, 'The Astor Motor Hotel' and 4125 East Hastings, 'The Admiral Hotel' as compared to any other half mile area without a drinking establishment. We can exclude the Sheraton-Villa in that it appears to be buffered by industrial and undeveloped land for most of the half mile radius, consequently, minimal amount of residential content is involved. The Lougheed Hotel at 4343 Lougheed Highway should be included. We know the crime statistics such as theft, breaking and entering, assault, drug trade activity, etcetera are recorded as a matter of routine. The Inspector cannot be serious when he states that 'we have not experienced any problems'.

Sir, many members of our community are still concerned with the question of increase in crime that does occur over a period of time in areas adjacent to drinking establishments. How can we possibly accept the Superintendent's report as complete when (a) we do not know exactly the full contents of your letter, (b) why twelve of the thirteen allegations were not even considered and (c) why the public at large is being prevented from presenting its briefs before the Council?

In addition, how can we consider Sup't. Thomas' report of October 16, 1978 to be complete when a member of his own department, Inspector King, appeared publically on television on February 4, 1978 and expressed his concern regarding the fact that 13 percent of the juvenile crimes committed in Burnaby are related to alcohol.

Is Sup't Thomas speaking on behalf of his own experiences, or does his letter represent the opinion of the whole Burnaby R.C.M.P. Detachment. How come a member of his staff was experiencing problems, even in February of 1978?

We petition you before the Council and request you to withdraw your letter of enquiry to Sup't Thomas from the protection of the rezoning application No. 12/78.

We challenge the Council to explore Sup't Thomas' letter separately from the rezoning application. We submit that the judiciary committee of the Council should also be involved.

If one is to consider the concerns expressed by the Crime Committee, as viewed on Cable 10 television, the Westridge area does not appear to be the only problem area. Juvenile alcoholic related crimes appear to be a problem throughout the North Burnaby area. We would like to localize the trouble areas. We are sure that a proper study of Alderman Ast's enquiry would be useful information for the Sperling Area Residents Organization as well as the Kensington Area Homeowners Organization.

On behalf of the concerned Westridge area residents, I petition the Council to withdraw all existing and planned public plebiscites related to new applicants for the establishment of alcohol dispensing facilities until a comprehensive report on crime activity, based on Burnaby statistics is compiled. We do not think that it would be a responsible action of the majority of the Council to turn our request down.

As taxpayers, we do feel that the Municipality of Burnaby does have the manpower and resources available for such a study. We request the Council to assist us with making such a report available to all of Burnaby citizens before any more plebiscites for alcohol outlets are permitted.

"THAT the Municipal Council of The Corporation of the District of Burnaby express its approval of the re-appointment of Mr. R.J. Guerin to the North Fraser Harbour Commission for a three year term as one of the two appointed Municipal representatives of the City of Vancouver and of the Municipalities of Burnaby and Richmond."

Alderman Lewarne drew attention to a recent press release from the Greater Vancouver Regional District which advised that the establishment of a Task Force to study possible sites for this facility to accommodate motorized recreational vehicles, such as trail bikes, motorcycles: and stock cars has been approved by the Greater Vancouver Regional District Park Committee. Alderman Lewarne suggested that this Press Release be referred to the Parks and Recreation Commission for their consideration and input to the Task Force established to study this question.
