On 1978 November 20, Council did not give reconsideration and final adoption to the subject by-law because a question was raised as to whether it contained a provision which would limit the amount of time that a vehicle could be parked in designated areas within the park. The Clerk has subsequently distributed a copy of the by-law to all members of Council for their information.

The recommendations adopted by Council on two previous occasions are as follows:

- A. 1978 October 23 Item 24, Supplementary Report No. 74
- "1. THAT the By-law be brought forward; and
- THAT the British Columbia Telephone Company be notified when the By-law has been adopted; and
- 3. THAT a copy of this report be sent to the Parks and Recreation Commission."
- B. 1977 February 21Item 17, Report No. 13

- "1. THAT Council authorize the Municipal Solicitor to prepare a by-law controlling parking in the Central Park lots in accordance with the regulations outlined in this report; and
- 2. THAT the by-law be submitted for approval to:
 - (a) The Burnaby/Vancouver Parks and Recreation Committee and, through this Committee, to the Vancouver Board of Parks and Recreation and the City of Vancouver.
 - (b) The Province of British Columbia; and
- THAT the B.C. Telephone Company be notified when the by-law is adopted."

Following are the regulations referred to in the first recommendation above:

- (a) Parking is to be for patrons of the park only, while within the confines of the park.
- (b) Maximum parking time is to be three (3) hours.
- (c) Regulations are in effect Monday through Friday from 7:00 h to 13:00 h.
- (d) Penalties for infractions to include ticketing and/or towing away.

The Parks and Recreation Commission approved regulations a, b. c. and d as noted immediately above on 1977 February 16.

It is apparent that the by-law as prepared and considered by Council on 1979 November 27 does not contain all of the specific regulations that were intended: items (b) and (c) were inadvertently omitted.
