

RE: LETTER DATED 1978 JUNE 14 WHICH APPEARED ON THE COUNCIL MEETING
AGENDA FOR JUNE 26 FROM DR. JOHN D. GRAHAM
REQUEST FOR "RESIDENT PARKING ONLY" SIGNS ON IMPERIAL STREET
AND COMPLAINING OF LITTER IN THE VICINITY OF THE CENTRAL PARK
PITCH AND PUTT COURSE

John D. Graham wrote to the Municipal Clerk on June 14 drawing attention to the litter conditions in the 3800 block Imperial Street as a result of the Central Park Pitch and Putt Golf Course. He expressed particular interest in a recent news item that he had seen which noted that the Burnaby Municipal Council was considering a new by-law permitting "Resident Parking Only" signs in and around the Burnaby General Hospital. He asked that Council consider the same action in his block, at least on the south side of the street.

The following is a report of the Municipal Engineer dated June 26 advising that this whole question is presently being examined by the Traffic and Safety Committee as a result of the petition from the Cascade Heights Area, and suggesting that Dr. Graham's request be tabled pending the outcome of the Committee and Council's decision on the Cascade Heights petition.

Attached to this report item is a copy of a report dated June 28 from the Chief Public Health Inspector in which he confirms that there is an excess of accumulation of litter in this area despite the action that we have taken to date. The Parks and Recreation Department will accelerate the removal of litter from the area, and we will be investigating the value of placing additional "no littering" signs within the Park and Golf Course area.

RECOMMENDATION:

1. THAT a request for "Resident Parking Only" in the 3800 block Imperial be tabled until a decision has been made on the previous request of the Cascade Heights Area for "Resident Parking Only"; and
2. THAT a copy of this report item be forwarded to Dr. Graham.



Re: LITTER AND PARKING COMPLAINT - 3800 BLOCK IMPERIAL STREET
COMPLAINANT: J.G. GRAHAM, M.D.

We would advise that the litter aspect of the above-noted complaint has been investigated by this Department. It is our finding that there is an excessive accumulation of litter in this area despite the fact that three (3) litter containers are situated on Imperial Street, two on the Park side and one on the residential side, and an adequate number of containers within the Golf Course and Park site. We are of the opinion that the major portion of litter is deposited by people leaving the Golf Course or Park area and prior to entering their cars.

We have discussed the situation with Mr. W. Spelay, Parks and Recreation official, who, as an interim measure, has instructed his personnel to accelerate the removal of litter from this area. In the meantime, we will investigate the value of placing additional "No Littering" signs within the Park and Golf Course area.
