Re: In Regards To The Proposed Pacific National Exhibition Multiplex I Believe We Have A More Important Project In Which To Devote Our Resources - That Is Rapid Transit.

A letter dated 1978 September 25 was received expressing the opinion that in regards to the proposed P.N.E. Multiplex, the writer believes we have a more important project to which to devote our resources. That is rapid transit.

To see the glaring need for rapid transit, one only has to remember what it was like driving in Burnaby/Vancouver five years ago or try travelling by subway in Montreal or Toronto compared to Vancouver.

A letter dated 1978 October 24 was received advising that the Ministry of Municipal Affairs and Housing has accepted the tenders of Cressey Development Corporation on Enclaves of 5 and 6 in the Harold Winch Park Project and looks forward to the developer reaching a satisfactory agreement with Burnaby for a comprehensive type of development compatible to the Municipality, the developer and the future occupants.

The Minister reiterated his staffs' comments that the Ministry stands ready to assist in ensuring the successful development of this project.

c) Conse-C Enterprises Ltd., President
Re: The Matter Of Building Safety Has
Been Of Concern To Us For Some Time.

A letter dated 1978 October 26 was received advising that the matter of building safety has been of concern to the writer for some time. Mr. Daem noted that approximately one year ago, they had suffered a rash of false alarms in three of their high-rise buildings located in the Lougheed Mall area.

This matter was discussed with a number of organizations and most recently they had been approached by the B.C. Telephone Company advising them that a simple system was available at a limited cost (\$16.95 per month) which would hook a telephone line into the fire alarm system and the telephone system of the resident caretaker, directly to the Fire Hall, with a pre-recorded message which would indicate the nature of the emergency, i.e., a fire alarm, and the address of the building.

This, therefore, left no room for human error and would eliminate the human elements and loss of time resulting from human intervention. It would also relieve the problem of a number of residents trying to reach the Fire Department at the same time.

Mr. Daem approached the Fire Department and was advised that it was not their practice to allow such a system but that the system could be installed through a third party, and we were appraised that A.D.T., a private security systems operation, was authorized by the Burnaby Fire Department to screen the calls for the Municipality and to install their system in our buildings. While this in itself did not cause us any great concern, on approaching A.D.T., we were appraised that it would cost \$1,700.00 to install their "system" and a \$1,700.00 per year maintenance charge. This represents \$3,400.00, multiplied by three is \$10,200.00 for our three buildings.

Council was advised that a staff report on this subject would be available on 1978 November 14 and further consideration of the matter was deferred until that time.

d) Province of British Columbia Ministry of Municipal Affairs and Housing Honourable H.A. Curtis, Minister Re: Payment Of The Seventh Installment Of The 1978 Unconditional Grant Pursuant To Part VIII Of The Revenue Shaing Act Regulations.

A letter dated 1978 October 13 was received enclosing Province of British Columbia cheque in the amount of \$739,600.00 which represents payment to the Municipality of Burnaby of the seventh installment of the 1978 Unconditional Grant pursuant to Part VIII of the Revenue Sharing Act Regulations.

e) T.A. Ritchie Re: I Will Not Be Wanting To Accept My Pin For Long Service

A letter dated 1978 October 30 was received advising that the writer would not be wanting to accept his pin for long service from the Corporation of Burnaby.

f) Gus Long
Re: Burnaby Should Be A Place
For People Not Cars

A letter dated 1978 October 20 was received concerning the brochure prepared by the Burnaby Transportation Committee on the "Comprehensive Transportation Policy".

The writer was of the opinion that Council's priority should be services to people, and particularly services to the children growing up in the east Burnaby area.

The writer suggested Council should concentrate on light rapid transit, a surface rail system and the use of smaller buses on many routes. The local bus, for example, never runs more than one-third full during off hours.

Mrs. Long advised that she was not prepared to spend one cent more on new highways and freeways while there are so many important issues that need to be dealt with. Burnaby should be a place for people, not cars.

Re: 1978 Grants In Lieu Of Property Taxes Municipalities
Aid Act And British Columbia Buildings Corporation Act

A letter dated 1978 October 13 was received advising that for 1978 the Grants in lieu are authorized under both the Municipalities Aid Act and the British Columbia Buildings Corporation Act. The combined amount of 1978 grant payments which will be made to the Municipality of Burnaby shortly is as follows, together with relevant 1977 comparisons:

1978 Grant \$ 605,557.58 1977 Grant \$ 281,609.63 Increase Over 1977 \$ 323,947.95 % Increase Over 1977 115.0%

Increases in grant amounts result from changes made in formula used to determine grants in lieu under the above Acts.

Under the Governments new policy, the Province and the British Columbia Buildings Corporation, pay grants equivalent to full municipal and regional district levies on all qualifying properties which they own using the same standard of assessment as that applied by the municipality in assessing other commercial and business property.

The overall increase in grants in lieu of property taxes in 1978 under the new program will amount to over \$4.2 million.dollars. This increase, coupled with monies which have been made available under other major municipal assistance programs, such as revenue sharing, school and university grants, sewerage facilities assistance, and removal of the administrative welfare, costs, is a further indication of the government's concern for the financial needs of its municipalities and is demonstrative of the initiatives it is taking to alleviate the tax burden on local property owners.

The Grants and Publicity Committee submitted a report on a request received from the Boys and Girls Clubs of Greater Vancouver for a tax exemption on their property at 516 Howard Avenue South, for the year 1979.

The Parks and Recreation Commission are recommending to Council that Council grant a tax exemption for 1979 on the property at 516 Howard Avenue South.

The Grants and Publicity Committee recommended:

1. Letter from Rape Relief which appeared on the Agenda for the 1978 October 30 Meeting of Council

The Municipal Manager provided a report from the Municipal Engineer regarding an incident in which a person was sexually assaulted at night on McKay Avenue, Burnaby.

The Municipal Engineer reported that the Transit and Electrical services of the British Columbia Hydro and Power Authority had been contacted to discuss the two requests contained in the letter from Rape Relief. The relocation of the bus stop onto Kingsway is not practical as it serves a westbound bus turning left to south-bound. In order to provide enough distance for this bus to leave the curb on Kingsway and cross two lanes of traffic to get into the centre lane to make a left turn would require that the stop be located considerably east of McKay Avenue. Hydro Transit also advised that due to different "headways" between buses, a scheduled meeting between the two buses referred to in the letter is not possible at this location.

The Community Services Representative for the Electrical Services investigated the possibility of installing a lease light on the nearest pole. The nearest pole, located on the east side of McKay Avenue opposite the bus stop, is not suitable for a street light installation. The only other option for improved street lighting along this section of McKay Avenue would be through a local Improvement program for ornamental street lighting.

The Municipal Manager recommended:

- THAT the Municipal Engineer be directed to issue initiative notices for ornamental street lighting along McKay Avenue from Kingsway south to Imperial Street.
- THAT Rape Relief be sent a copy of this report.

2. Subdivision Reference #52/78
Proposed Right-Of-Way Across Municipal Property
Lot 2, D.L. 138, Plan 50726

The Municipal Manager provided a report from the Director of Planning regarding subdivision reference #52/78.

As a point of clarification, the legal description in the recommendation refers to proposed lots 1 through 11, inclusive, as noted on Sketch 1 of the Director of Planning's report. In other words, the entire easement is on Municipal property (no private property is included). The recommendation is simply intended to make provision for the necessary easement before the individual lots are created and advanced to a sales position.

The Municipal Manager recommended:

1. THAT Council authorize the Corporation to grant itself a 3.0 m (9.843 foot) easement over Lot 2, D.L. 138, Plan 50726 for sanitary sewer purposes to serve the subject subdivision as more particularly described in the Director of Planning's report.

3. Fire at 9900 Block Barnet Highway on 1978 October 14

The Municipal Manager provided a report from the Director - Fire Services and the Municipal Engineer on the above subject.

The Director - Fire Services provided detailed information on the questions raised in Council on 1978 October 16 on this subject.

The Director - Fire Services concluded his report by noting that to project a course of action in fire fighting is most difficult due to the many variables involved. As such, it becomes most obvious that the art of fire fighting is, by necessity, an inexact one, calling as it does for instant command decisions before all of the facts can be established.

Having stated the foregoing, it must be concluded that each instance has to be evaluated at the time of occurance and as such precludes a set pattern of approach.

This, of course, does not preclude the obvious need for a close interdepartmental relationship between Fire - Police - Engineering - Health and the private carriers to establish an effective working relationship in the disaster area.

The Municipal Engineer provided detailed answers to the questions raised in Council on 1978 October 16 relative to his department's responsibility with regard to the Barnet Highway.

The Municipal Engineer reported that on 1978 October 30, a meeting was held with officials of the Ministry of Highways and Gulf Oil to discuss the measures that could be taken to lessen the possibility of future accidents at the main access to the Gulf Oil Refinery. In the long term, during the future upgrading of the Barnet Highway, raised channelization will be provided for the left turning traffic into the westerly south driveway and the north driveway in Port Moody. The easterly driveway on the south side will be restricted to right turns out only. In the interim the Ministry of Highways are prepared to install a vehicle actuated signal at the westerly driveway. This signal will include the standard advance flashers "Prepare to Stop when Amber Flashing". They also advised that they will be reducing the existing 80 kmh speed limit to 70 kmh and placing advance warning signs of gasoline trucks turning ahead.

In summary, the immediate action taken on the Barnet Highway will be:

- 1. Install larger advance signing warning of gasoline trucks turning.
- 2. The installation of additional lighting at bus stop locations and at all major access locations. These lights to be sodium vapour if possible.
- 3. Reduction of the existing 80 kmh speed limit to 70 kmh.
- 4. Consideration of a vehicle actuated traffic signal with advance warning flashers.

In the longer term, the Ministry of Highways will be upgrading the entire length of the Barnet Highway to a four-lane standard. During the design of this upgrading consideration will be given to providing channelization where possible for left turns into major vehicle access points.

4. Schedule of Fee Amendment - By-law #5096 Burnaby Fire Prevention By-law (1968)

- 2. THAT the basis for such fee schedule be established at two hours of a Fire Inspector's hourly rate plus administration costs for each inspection (\$20.75 + \$3.25 = \$24.00).
- 3. THAT such fee schedule be reviewed annually.

The Municipal Manager provided a report from the Director of Planning regarding the proposed Smith Avenue Underpass.

The Director of Planning reported that the British Columbia Hydro and Power Authority, Railway Freight Division, has advised Burnaby staff that commencing 1978 December 04, Hydro will commence filling with enbankment material the old concrete railway structure which crosses over the former Smith Avenue roadway including that portion which currently serves as a pedestrian undercrossing of the railway.

British Columbia Hydro and Power Authority staff have indicated in writing that they would be prepared to preserve the pedestrian crossing facility during the filling operation if Burnaby supplied the "pipe" underpass.

The Municipal Manager recommended:

1. THAT Council authorize the expenditure of \$31,800.00 for the pedestrian facility from contingency.

12. Lease from Timberlea Strata Corporation Municipal Entrance Sign

The Municipal Manager provided a report from the Parks and Recreation Administrator regarding the proposed establishment of a location for a Municipal entrance sign.

The Municipal Manager recommended:

1. THAT the Council authorize the execution of a ninety-nine year lease with the Timberlea Strata Corporation as described in the survey plan dated 1978 October 17 for the purpose or erecting a Burnaby Entrance Sign at Lougheed Highway and Austin Road, at a nominal cost to the Corporation in the total amount of One Dollar.

13. Shelter for the Residents of Seton Villa

The Municipal Manager provided a report from the Municipal Engineer on a request by Council that consideration be given to the feasibility of installing a bus type shelter midway between Hastings Street and Seton Villa for the benefit of residents who use this route.

The Municipal Engineer reported that while there was no question that it would be feasible to install a bus type shelter in the suggested location, he would question the desireability of embarking on such a program. It is not a question of these citizens wanting to catch a bus as they have a bus stop within one block of Seton Villa. They are, therefore, doing what a citizen in any number of such developments might do, go for a long walk. The other concern we would have would be the confusion that would arise if we were to start placing bus type shelters on streets not being used by buses. As an example, we had a case not long ago where one of the companies that installs bus benches in Burnaby placed a bench at a non-bus stop location. We soon received complaints from citizens who had spent some time sitting on the bench before they realized that the bus was not going to pick them up.

We would add at this time that when we commence installing bus shelters stops, the stops at Eton Street and Esmond Avenue will be among the first thirty shelters.

The Municipal Manager recommended:

1. THAT bus type shelters and benches be used only at designated bus stops.

MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN MERCIER:
