#### **RECOMMENDATION:**

1. THAT the Highway Exchange By-law be brought forward.

### REPORT

Council, on 1979 June 18 (Manager's Report No. 43, Item 13) authorized the introduction of a lane closing by-law for the captioned subject. The area of lane is 930 m<sup>2</sup> (9,995 sq. ft.); however, a bus bay dedication of 153 m<sup>2</sup> (1,650 sq. ft.) is required on Hastings Street (see attached sketch).

Since the applicant is required to dedicate a portion of land on Hastings Street for a bus bay, we have suggested that the allowance be closed via the Highway Exchange avenue. The Land Registry Office has been contacted and it is reported that this procedure is feasible.

Therefore, for Council's information, we would outline the conditions to be satisfied for the proposed highway exchange:

- Consolidation of the lane allowance with the proposed site.
- 2. Removal of all Municipal, B.C. Hydro and B.C. Telephone facilities located within the lane allowance.
- 3. Payment of compensation by the owners to the Corporation of \$12.00 per square foot for the balance of the lane after exchange. It is advised that the amount of compensation which has been established was calculated by the Legal and Lands Department.

Therefore, the amount payable to the Corporation for the balance of the lane is \$100,140.00.

4. Submission of all necessary consolidation and highway exchange plans.


The Planning Department has received written concurrence with the above conditions from Bosa Bros. Construction Ltd.
