RECOMMENDATION:

1. THAT the lowest tender to meet the Municipal Specifications, submitted by Tower Precast Limited in the amount of \$20,480.00, be accepted.

REPORT

Tenders for this supply contract were received up to 1500 h local time on Monday, 1979 September 17.

The work includes the manufacture and delivery of approximately 200 precast concrete exposed aggregate litter receptacles in accordance with Municipal Specifications.


Six (6) tenders were received and opened in the presence of Messrs. R. Constable, J. Hagen and representatives of the firms bidding.

A tabulation of the tenders received is attached.

On Friday, 1979 September 21, Mr. MacKenzie Ross of the Engineering Department, Contracts Division, visited the plant and inspected the precast operation of the low bidder Goodbrand Construction Ltd. While the operation was adequate for mass precast concrete work, the facilities for the manufacture of exposed aggregate precast concrete were such that the company could not meet our specifications. Mr. Ted McCallum, the Company's Plant Manager, agreed with our assessment of the facilities.

On Monday, 1979 September 24, Mr. Ross carried out a similar inspection of the plant of the second low bidder, Tower Precast Limited and found their operation satisfactory. We would, therefore, recommend that the contract be awarded to Tower Precast Limited.

The Municipal Engineer advises that he concurs with the recommendation.
