#### REPORT

The Engineer submits the following recommended projects, for Council's approval, to be included in the 1979 Drainage Bylaw. The funds for the proposed Bylaw were provided in the 1979 Capital Budget.

The program consists mainly of projects that have a high priority rating because of maintenance problems and attendant high maintenance costs. The unspecified section of the Bylaw will contain projects which are presently under review by the Engineering Department to establish their relative priorities; the projects in this section generally have a slightly lower priority rating than projects in the specified section.

Place Edmonds - Mary to New Vista

The street is improved but there is no storm sewer; flooding problems occur from time to time.

to L/N Ringsway

T/E leth Avenue - Humphries; A variety of non-standard culverts have been installed in the ditch causing maintenance and flooding problems.

Fell - Dundas north to cul-de-sac

Deep unsightly ditch plus maintenance problems.

Lane - Royal Oak to Kingsway

Flat grades cause maintenance problems.

Ellerslie Ravine

This is a potentially very dangerous situation if the existing sewer should cease to function or slippage occur because of the depth of the sewer and the steepness of the slope. The system must be completely reconstructed.

Warwick - Pandora to Dundas

Flat grades; water "ponds" (will not run away).

Gilley - Imperial to Kingsway

Flat grades; water "ponds" (will not run away).

Gilpin - Mahon to Deer Lake Place

Messy and flat ditches which need to be eliminated for efficient maintenance.

Springer - Lougheed to Douglas

Deep ditches; high cost of maintenance.

Douglas - Lougheed to Burlington Northern

Deep ditches; high cost of maintenance.

L/N Oxford - Willingdon to Rosser

Flat grades; water "ponds" (will not run away).

L/S Arbroath - Gilley to school property 

Ditch has been piped but commercial building of necessity discharges onto lane which causes icing problems.

Sherlock - Curtis to Kitchener Flat grades; flooding problems occur because of substandard piping of ditches.
