A letter dated 1979 August 01 was received providing additional information on Mr. Kerbel's request for the removal of the "No Parking" restriction on Norland Avenue adjacent to 2701 Norland Avenue. Mr. Kerbel pointed out that a great number of the vehicles which have been parking in front of the K.Y. Coffee Shop are not huge tractor trailers, but rather are small vans and service vehicles which move around the area, picking up and delivering to the various trucking companies and suppliers.

Mr. Kerbel respectfully suggested that the parking of these vehicles in the area would not impede traffic to any degree which should cause concern; alternatively, the Council or the Traffic Committee might want to consider whether the curb could be removed, and vehicles could be allowed to park on the shoulder, off the paved portion of the highway.

Burnaby Public Library Board, Chairman
 Re: Role of the Greater Vancouver Library
 Federation

A letter dated 1979 August 02 was received providing Council with the Burnaby Public Library Board's Commentary concerning a letter addressed to Council dated 1979 July 17 from The Honourable Hugh A. Curtis, Minister of the Provincial Secretary and Government Services concerning the role of the Greater Vancouver Library Federation.

The Chairman of the Burnaby Public Library Board trusted that Council will share his opinion that local support of the Greater Vancouver Library Federation and of Public Library Service within Burnaby fully justifies any sympathetic consideration that the Minister may wish to give to the concept of supplementing Provincial Grants especially and specifically to enable library automation to be carried out more quickly, more comprehensively and more systematically, than could otherwise be achieved by relying upon municipal funding alone.

These contradictions are indicated by the fact that the 5000 Block Canada Way meets the requirements of heavy traffic volumes on frontage roads which would require the construction of a back lane, but this policy was not applied at the time of development of the 5000 Block Canada Way when Rugby Street, or a lane, could more easily have been extended to Haszard Street.

A letter dated 1979 August 07 was received advising that the residents of Burnaby Heights and East Vancouver, in the vicinity of the proposed site of the highrise towers in the 3700 Block Albert Street were forming a Committee to protest the proposed development.

The writer was of the opinion that more appropriate buildings could be erected which are compatable with the residential area and which would tend to alleviate the congestion of traffic rather than worsen it. The writer would like to see the Community Plan revised for this area before the campaigning begins for the upcoming election.

From a Street Connecting to Norcrest Court Through
Lot 136

A letter dated 1979 August 03 was received protesting the proposed subdivision of approximately five acres of land, west of Norcrest Court and south of East Broadway in Burnaby, into 21 single family dwelling lots with the sole access being from the street connecting to Norcrest Court through Lot 136.

The traffic along Norcrest Court has already reached such levels that the residents will shortly be petitioning to have the street closed off. To add the potential volume of more than double the number of residents now on Norcrest Court to the flow of this already over-burdened street would surely have a negative impact on the area.

Surely, rationality will prevail and the welfare of the present property owners and tax payers will be given full consideration when this most important decision is made. The writers requested that Council quash this proposal.

Re: Sponsoring A Refugee Family

A letter dated 1979 July 20 was received advising that the Council of The Corporation of the City of Kitchener on 1979 July 16 had adopted the following resolution:

"WHEREAS the Government of Canada and the Governments of the Provinces of Canada have demonstrated moral leadership in regard to the problems of the refugees of Vietnam; and

WHEREAS the City of Kitchener recognizes the responsibility of Municipal Governments in Canada to demonstrate moral leadership on social issues as well.

THEREFORE BE IT RESOLVED that in an effort to alleviate the suffering of some of these Vietnamese refugees, the City of Kitchener, on behalf of its citizens, proposes to agree to sponsor a refugee family, when Provincial enabling legislation allows, in the hope that this action will stimulate other community organizations and citizens of Kitchener, as well as other Ontario municipalities, to also offer these people the freedoms, rewards and responsibilities of Canadian Citizenship.

AND FURTHERMORE, that this Motion be circulated to Municipalities in the Province of Ontario and the larger Municipalities of Canada.

AND FURTHERMORE, we request the Government of the Province of Ontario to pass necessary enabling legislation as soon as possible."

It was requested that this matter be placed before the Municipal Council for consideration in the event that it sees fit to endorse the principles contained therein, to so advise the Prime Minister of Canada and the Provincial Premier. It was further requested that the City of Kitchener be advised of any action taken by Burnaby Council in this respect.

t) Greater Vancouver Regional District
Commissioner, Finance and Administration
Re: Vietnamese Refugees
("Boat People Rescue Project")

A letter dated 1979 July 31 was received advising that the Greater Vancouver Regional District Board of Directors at its meeting on 1979 July 25, had adopted the following resolution:

"THAT the G.V.R.D. approve full support of the program initiated by the City of Vancouver to prepare plans for the reception and accommodation of Vietnamese refugees and to request Member Municipalities to approve funding support and other assistance as may be required and to approve participation in the Task Force which has been set up to deal with this matter, specifically:

- Each municipality to be requested to approve a contribution of funds for the organization of the program within the municipality.
- Each municipality to be requested to conduct a public fund-raising drive with contributions to the Mayor's Office in each municipality.

- Each municipality to be requested to assist in the compilation of a housing inventory and join in efforts to encourage residents to offer accommodation and to offer sponsorships for refugee families.
- 4. Each municipality to be requested to appoint a representative to be part of the overall Task Force to assist in the planning of the program."
- u) Union of British Columbia Municipalities, President Re: Refugee Settlement Program

A letter dated 1979 August 02 was received drawing Council's attention to some actions which have been taken by public bodies to assist in the settlement of refugees from Southeast Asia.

The President of the Union of British Columbia Municipalities was sending this letter as a personal request so that each Council and Regional Board might consider what role they can play in helping these refugees.

Perhaps Council can emulate the decision of the City of Vancouver to act as a clearing house in the local community to direct those refugees to local groups and organizations which are able to house them until they find a place to live and to work. No doubt there are various church organizations and service clubs in your municipality or Regional District which could sponsor and assist those refugees and the local government could help these groups by co-ordinating their efforts and generally acting as an expediter. The Municipality may also have a role to play in directing them towards available housing and accommodation

Council's knowledge of the community and its resources is well suited to accomplish such a task and the President urged Council to take whatever initiatives they can develop locally to welcome and assist these unfortunate families.

ENQUIRIES

Alderman Gunn

Alderman Gunn noted that there had been some very bad air quality problems in the Greater Vancouver Regional District and particularly in North Burnaby during the past week. The problems were the worst encountered by Alderman Gunn in the last 12 to 13 years. Alderman Gunn had been advised, in his conversations with the G.V.R.D. Inspector, that it had not been possible to pinpoint the source or the cause of these occurrences Alderman Gunn requested that the Municipal Staff report, through the Greater Vancouver Regional District, if required, on the occurrences of the past week in terms of air quality in the Greater Vancouver Regional District and particularly in North Burnaby. This report should contain information on the actual nature and location of the problem, if the G.V.R.D. is able to identify the cause and what action the G.V.R.D. can take in this respect. Information was also requested as to whether the G.V.R.D. can get equipment to actually measure this type of problem on site rather than depending on the existing testing stations.

His Worship, Mayor Constable, suggested that enquiries also be made of the British Columbia Hydro and Power Authority who also receive complaints of this nature and do some investigative work.

Alderman Mercier

Alderman Mercier indicated that he would be introducing a "Notice of Motion" at the Council meeting on 1979 August 27 concerning traffic conditions in the vicinity of the P.N.E. Grounds.

Alderman Lewarne

Alderman Lewarne drew Council's attention to a letter received from the City Clerk, City of Vancouver, regarding the development of Boundary Road. Alderman Lewarne enquired as to whether the cutting referred to in this letter referred to the material movement for a cut or for the cutting of trees.

The Municipal Engineer advised that the cutting referred to in the City Clerk's letter involves grade cutting only.

The Municipal Engineer further advised that the Vancouver City Council at its next meeting will consider a tender in the amount of \$193,000.00 for the excavation which is the heavy part of the work.

Alderman Lewarne requested that the intent of the City Clerk's letter be clarified.

Alderman Drummond

Alderman Drummond noted that at a recent meeting of the Refineries Fire/ Security Committee, the Committee had been advised that there was a possibility of the movement of propane by a super-tanker from the Westridge Terminal and enquired if there was more definite information available on this subject.

His Worship, Mayor Constable, advised that he would take follow-up action on this enquiry.

b) The closure of the hitherto unconstructed portions of 18th Avenue and 16th Avenue and the inclusion of this land within the proposed park/trail system in the area.

c) The rezoning of the properties involved to the P3(Park and Public Use) District category, and the turning over of these to the Parks and Recreation Department.

- d) The proposed staging program for the development of the park trail system, as shown on Plan #3.
- e) The Planning Department initiating approaches to the owners of 7032 and 7042 19th Avenue (Lots 24 and 23, Block 2, S.D. 47, D.L. 97, Plan 1981) and authority for the Legal and Lands Department to obtain easements through the southerly halves of these properties for park/trail continuity and upkeep, and that failing this they also be included in the Park Acquisition Program; and also a similar approach to the owner of 7077 Eighteenth Avenue for the westerly thirty feet only of this property (see Part II of the Implementation Plan).

f) The inclusion of the privately-owned properties within the Ravine area in the Park Acquisition Program. (See Part II of the Implementation Plan for properties involved and phasing).

- g) A detailed investigation of the water quality in this area of the creek to determine individual sources of pollution, with a view to stricter enforcement of anti-pollution standards, in order to improve the water quality.
- THAT Council adopt the conceptual plan, design standards and estimates prepared for allocation of the remaining Eastburn N.I.P. budget to achieve this summer those specific improvements outlined in the Plan.
- 3. THAT Council approve in principle the rezoning to R3 of those presently owned Municipal lots referred to in Part IV of the Implementation Plan: and THAT these properties be held in reserve and offered to local residents affected by the above recommended property acquisitions as a first priority, after which they then be offered for sale publicly by the Legal and Lands Department.
- 4. THAT Council authorize the preparation and execution of a Restrictive Covenant pursuant to Section 24A of the Land Registry Act for the preservation of trees on the aforementioned lots.
- 5. THAT Council approve in principle the long-term area plan put forwaffor the future development of this neighbourhood as shown on Plan #4.
