RE: IRRIGATION SYSTEM
MUNICIPAL HALL, WEST BUILDING AND THE JUSTICE BUILDING

Following is a report from the Parks and Recreation Administrator regarding proposed additions to the irrigation system adjacent to Municipal Hall.

The request for approval to spend \$10,000 includes the \$8,730 for an extension of the system into Areas C, D, E, F and G, and also \$1,270 for the proposed upgrading of an existing system.

RECOMMENDATION:

1. THAT the recommendation of the Parks and Recreation Administrator be adopted.

RECOMMENDATION:

1. THAT Council approve the expenditure of \$10,000.00 for the installation of additional irrigation and the upgrading of an existing system as more specifically referred to in this report.

REPORT

An on-going program of upgrading the Municipal Hall grounds has been in effect for the past two years. This report is being submitted as part of the on-going upgrading of the irrigation portion of the overall program for 1979. Future upgrading reports will be submitted at a later date.

Improvements are required in the irrigation system for 1979 and are designated as Areas C, D, E, F and G on the attached plan.

During site development, work extending from the Municipal Hall renovation program had some areas omitted from the irrigation system. In 1978, Parks and Recreation staff were asked to include the areas deleted during this site development. \$10,000.00 is included in the 1979 C.I.P. budget for this work. Areas recommended for inclusion are as shown:

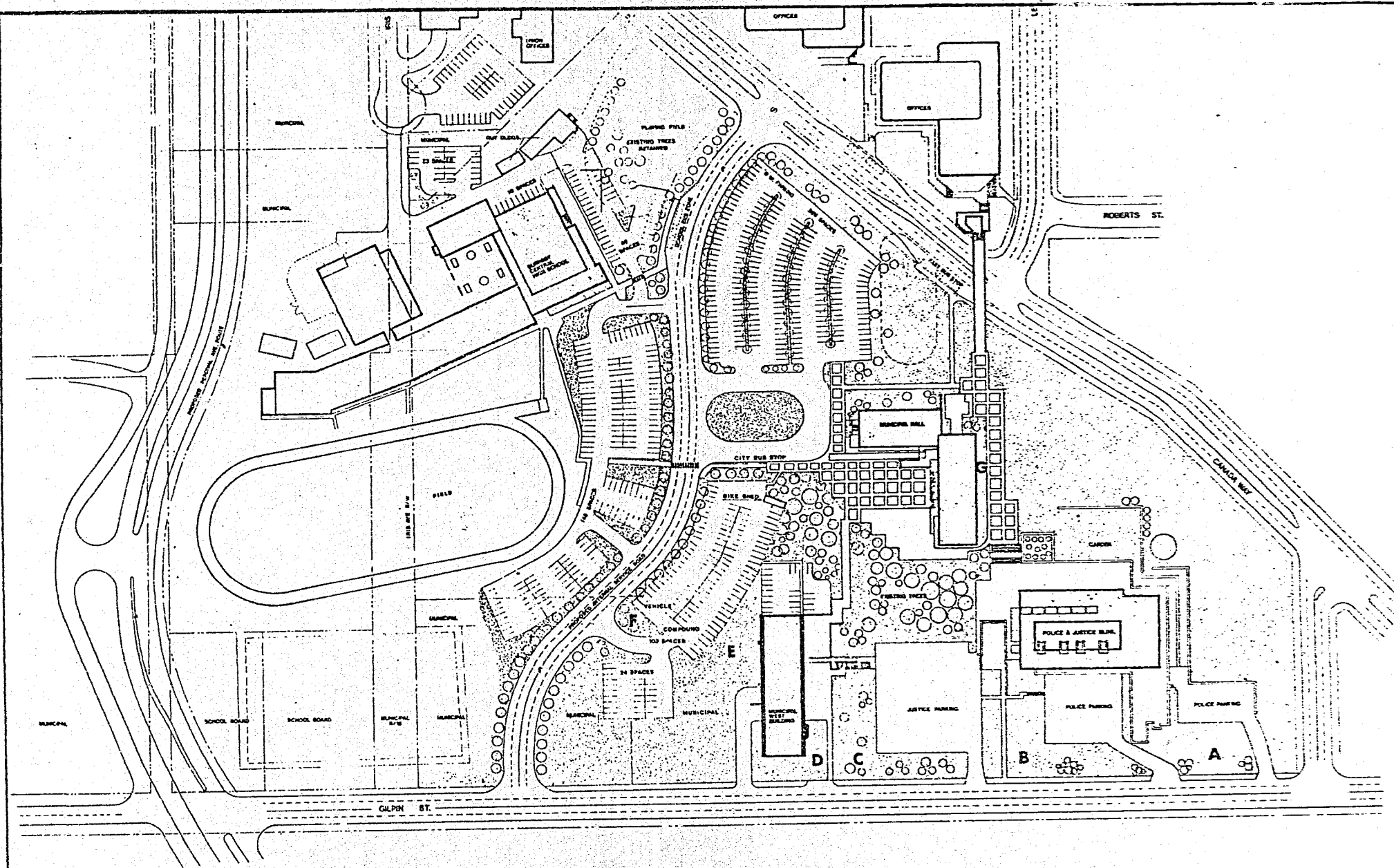
An amount of \$1,270.00 is required to upgrade the existing irrigation system north of the Municipal Hall and west of the pedestrian overpass. It is required to change the risers due to excessive vandalism. The plastic risers will be replaced with brass risers.

Areas A and B will not be done at this time. The upgrading of the system north of the Municipal Hall and west of the pedestrian overpass will take place instead. The deletion of Areas A and B is due to the possible extension of the Justice Building.



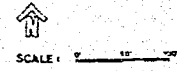
