During this second quarter of 1979, the housing survey has proceeded in the North Burnaby area bounded by Kensington, Curtis, Cliff, and Hastings Streets. In this area, as of June 20, a total of 219 properties have been visited. Ninety-nine dwellings still have to be visited, and it is estimated that the survey of this area could be completed by the end of July. In the survey 16 duplexes have been inspected or are in the process of inspection, and of this number, three have been found to contain unauthorized suites.

Following the commencement of the housing survey in March 1978, we received and began to handle complaints from citizens against alleged unauthorized suites. In August 1978 it became departmental practice to identify the complaint investigations for record purposes - prior to August the complaints had been handled by the field Building Inspectors and were not identified for the housing survey records. In the period from 1978 August 18 to 1979 June 20, the Housing Inspector has investigated 115 such complaints, and at this date 88 more complaints are awaiting investigation. The 115 figure does not include any repeat or duplicate complaints on subject addresses. For example, a subject address will be investigated and may be found in violation. Following notice given and reinspection, the premises may be found to be in compliance. Shortly thereafter a second complaint may be received and the same premises again found to be in violation. This type of case requires extensive follow-up and generally has to be prosecuted before permanent compliance is achieved.
