REPORT

In 1978 the Second Street School Parent's Association began working on a project to improve the playground facilities at Second Street School. In April of 1978 a "Big Toy" climbing apparatus was installed on the playground which was paid for with \$2,500 from the Eastburn NIP project and with \$1,010 raised by the Parent's Association, and was installed by the Burnaby School Board.

CURRENT PROPOSAL:

The existing "Big Toy" installation has proven very successful and a proposal for further development has been discussed between the Parent's Association, the Eastburn NIP Committee and the Burnaby School Board for the past several months.

This project will be used by the 260 children enrolled at Second Street School and will be available to children in the neighbour-hood at all times when the facilities are not in use by the school. This project has been supported by the Eastburn NIP Committee as a result of a neighbourhood questionnaire circulated in the planning stage of the NIP project which identified a need for playground facilities for children in the Second Street area.

The improvement of the school playground is seen as being a good alternative to the Second Street mini-park proposal that was not pursued due to concerns about the impact and location of the new park that had been proposed.

The proposed project was approved by the Burnaby School Board on 1979 March 16. The Board will undertake the maintenance of the equipment. The installation work will be done by School Board staff.

The proposal includes,

"Big Toy" addition, 4 basketball standards, 5 outdoor picnic tables, 1 outdoor volleyball court, nets and poles.
