1. THAT a purchase order be issued to the lowest bidder, Carter Pontiac Buick Limited to supply three GMC Model TC 31306 1980 Vans for the sum of \$26,123.76, including applicable taxes.
2. THAT a purchase order be issued to the lowest bidder, Casey Dean Lincoln Mercury Sales Limited to supply two Ford L800 Trucks complete with 5 - 7 cubic yard Dump Bodies for the sum of \$45,393.92, including applicable taxes.
3. THAT a purchase order be issued to the lowest bidder, Carter Pontiac Buick Limited to supply one GMC 1980 Model 3/4 Ton Pick-up for the sum of \$7,597.20, including applicable taxes.
4. THAT a purchase order be issued to the lowest bidder, Carter Pontiac Buick Limited to supply four 1980 Model "S" 7T JOB Acadians for the sum of \$17,426.24, including applicable taxes.
5. THAT a purchase order be issued to Courtesy Chevrolet to supply one 1980 Chevrolet Four-Door Station Wagon Model CC 10906-ZW9 for the sum of \$9,370.40, including applicable taxes.
6. THAT a purchase order be issued to the lowest bidder, Casey Dean Lincoln Mercury Sales Limited to supply one 1980 Ford C 700 Tilt Cab & Chassis for the sum of \$14,950.00, including applicable taxes.

All tenders were opened in the presence of Messrs. Constable, Nuttall and representatives of the firms bidding.

Tabulations of the tenders received are attached.

Funds have been provided in the 1979 Capital Budget.


Items numbered 1, 2 and 3 are for use in the Engineering Department. The lowest tender received for each category satisfied the specifications and is therefore acceptable.

Item number 4, replacements for the Municipal Hall Fleet, the lowest offer submitted by Carter Pontiac Buick Limited for these vehicles, satisfies our requirements.

The Four-Door Station Wagon and the Tilt Cab and Chassis are for use in the Fire Department. The lowest tender received for the Station Wagon was submitted by Carter Pontiac Buick Limited in the amount of \$9,342.32. Their bid fails to comply with our specifications in two areas. Conventional Bias Belted Tires have been offered in place of the specified Michelin "X" Radial and the windshield is not tinted as requested. The second lowest tender submitted by Courtesy Chevrolet in the amount of \$9,370.40 is only \$28.08 higher and satisfies all sections of the specifications.

The lowest tender for supply and delivery of the Tilt Cab and Chassis submitted by Casey Dean is acceptable in all respects.

The Municipal Engineer and the Director-Fire Services concur with the recommendations.
