## REPORT


The Parks and Recreation Commission and the Municipal Council on 1979 October 17 and 29 respectively approved the execution of a 99-year lease with the St. Thomas More High School and Our Lady of Mercy Church on property required for the installation of a Burnaby Entrance Sign. Since that time, the Lessor's legal counsel has recommended that the term of the lease be limited to a 25-year term with the Municipality having the option of renewal. In addition, discussions with representatives of St. Thomas More School has led to changes in the extent of the leasehold area as shown on the attached sketch. The Commission, at its moeting of 1979 December 05, approved the proposed amendments.
