


1. THAT the B.C. Assessment Authority be requested to implement a change in house numbers on Pandora Drive, and

REPORT

Appearing on the agenda for the 1979 January 02 meeting of Council is a report from the Municipal Manager arising from a letter submitted by Mr. & Mrs. Mork regarding the similarity of house numbers and associated problems on Pandora Street and Pandora Drive.

Subsequently a letter has been received from Mrs. R. Roman (see attached) which does not appear on the agenda but is directly related to this subject. Reference was made to the fact that the Assessment Authority has expressed willingness to have the numbers changed on Pandora Drive, and this has been confirmed in a telephone conversation with the Area Assessor.

Therefore, due to the confusion being experienced as a result of the close proximity of these streets and the similarity of house numbers, it is recommended that the Assessment Authority be requested to effect such a change.
