Mr. A. Branca then addressed Council and advised that he was representing property owners and tenants in the area between Douglas Road and Westminster Avenue in Burnaby. Mr. Branca further advised that he was present this evening to request Council to give consideration to rezoning the area under discussion to a category which would permit the rental of additional suites in the existing duplex dwellings. Mr. Branca stated that his clients were amazed that the Building Inspector had the right to enter premises for inspectional services without the benefit of a warrant. Mr. Branca had advised his clients that under the terms of the Municipal By-law, the Building Inspector did have the authority to do just that.

Mr. Branca presented a petition prepared by his principals and signed by sixth-two property owners and forty-nine tenants indicating that they were all happy with the current situation and would like to see Council authorize rezonings in the area to bring the situation into conformity with the Burnaby Zoning By-law.

Mr. Branca noted that the area in question had developed very rapidly into a predominantly multi-family area on large sized lots. The older homes that are being bought are being replaced by more modern structures that lend themselves to fourplex style. There had been no objections on the part of the Building Inspectors to the houses in question. They are obviously planned as fourplexes but the plans themselves specify "duplex only".

Mr. Branca then reviewed the economics of owning, operating and renting of a fourplex in this area.

Mr. Branca was of the opinion that the Building Department was fully aware that a large number of these duplexes were being converted to fourplex status and was tacitly condoning and compounding what has been done.

Mr. Branca also contended that the population density of the area was not unduly affected by the conversion of duplex dwellings to fourplex status. The area is a popular one and rentals are considered reasonable by all involved and are rentals that can be afforded by the people living there.

Mr. Branca summarized his presentation by stating that there has almost been an implied agreement in this area that a duplex may be used as a quadraplex. Inspectors have inspected the structures that obviously are quadraplex although they were applied for as duplexes. Mr. Branca believed that building permits were still being issued for this type of structure and he was of the opinion that any restrictions should apply to new construction only.

Mr. Branca thanked His Worship, The Mayor, and Members of Council for their consideration and expressed the hope that they would find the situation outlined here this evening merits the relief he and his clients have requested.

All Municipalities are to receive larger grants in 1979 than in 1978. Even those Municipalities receiving modest increases in 1979 were the beneficiary of much larger increases last year. Every community is much better off in 1979 than it was before Revenue Sharing was introduced.

The Unconditional Grants will account for more than 75 percent of the total value of revenue sharing in 1979. Details of the other programs will be announced later.

Alderman Randall further enquired as to the present status of the Oakalla Lands.

His Worship, Mayor Constable, advised that the Committee had made a recommendation to the responsible Minister who at that time was the Honourable Alex Fraser. Late last year the portfolio was changed and it went to the Honourable H.A. Curtis. The Mayor has written to the Minister now responsible and has also discussed the matter with him verbally. The Mayor had been assured that the Minister would be making an announcement once he has had an opportunity to review the recommendations of the Committee. Mayor Constable indicated that he would make another approach to the Minister in this respect.

Alderman Randall enquired as to the present policy of placing Municipal advertising in newspapers. Alderman Randall noted that the Vancouver Sun and the Vancouver Province had been on strike for a lengthy period and enquired if Municipal advertising was being placed in local newspapers circulating in Burnaby other than the Columbian.

Alderman Randall did not think that the Columbian had a large circulation in Burnaby and suggested that consideration should be given to placing advertisements in local Burnaby newspapers.

The Municipal Manager advised that it was policy to advertise in the newspapers providing greater coverage which is the Columbian. Municipal advertisements covering public meetings to be held in the near future had been placed in the Boundary Road and the South Side Times.
