Following is a report from the Parks and Recreation Administrator regarding a proposal to execute a lease for the installation of an entrance sign on Kingsway.

The low maintenance landscaping would consist primarily of trees and shrubs in bark mulch fronted by a grass strip with a small flower bed around the sign. A provision in the amount of \$1,350 will be set aside in the 1980 budget for this work. PECOMMENDATION:


The attached report from the Director of Planning dated 1979 September 25 was received by the Parks and Recreation Commission at its meeting of 1979 October 17, and approved.



PARKS AND RECREATION ADMINISTRATOR

RECOMMENDATIONS:

1. THAT the Parks and Recreation Commission endorse the proposed lease and entry sign/landscaping project and recommend approval to the Municipal Council.

REPORT

Pursuant to the Burnaby Beautification Committee's program involving the installation of entry signs at major entrance points of the Municipality, the Committee on 1979 May 03 authorized two of its members to meet with officials of the St. Thomas More High School and Our Lady of Mercy Church regarding the possibility of installing an entrance sign and landscaping on their respective properties adjacent to Kingsway.

The proposed entrance sign and landscaping together will cover an area approximately 9.75 m (32 ft.) wide and 155.2 m (510 ft.) long (refer to <u>attached</u> Sketch). An appropriate plan illustrating the location of the entrance sign and landscaping details has been prepared and submitted to the Church and School authorities who have agreed in principle to the proposal on the understanding that the said area would be leased to the Municipality.

The monies required to install the works will be obtained from the Burnaby Beautification Committee's 1979 Operational Budget under item 2 - "Entry Signs". It is intended that the leased area will be maintained by the Parks and Recreation Department, as are the other three entry sign locations.

In order to implement this proposal, it will be necessary for the Municipal Council to authorize the preparation of an appropriate long-term lease with the Church and School. The lease should include a 99-year term for a nominal sum of \$1.00 per year, and should require the Municipality to maintain the specified area.


