The noise level is high.

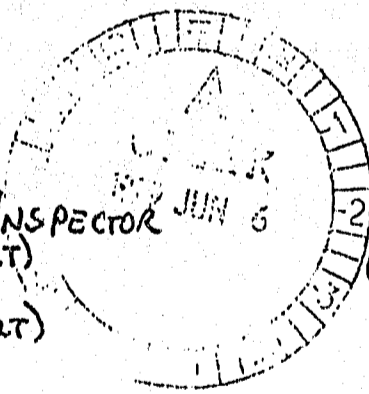
Second, some cars use this road as a
