- 2. THAT the Municipal Solicitor bring forward the required amending bylaw.

## REPORT

In a report to Council dated 78 06 19, Item 17, Manager's Report No. 46, Council adopted the following recommendations:

- "1. THAT the Burnaby School Board be designated as having No. 1 priority as a commercial customer;
- 2. THAT the Corporation pick up commercial refuse accounts on a controlled basis to the limit of our capabilities without disruption to our commercial customers;
- 3. THAT the following charges, which represent the updated "going rates" for rental and collection of all containers, be approved:

4. THAT the Burnaby Refuse Bylaw be amended to reflect the charges tabulated above."

At that time it was agreed that the Corporation of Burnaby would charge the "going rates" for commercial collection and disposal.

In the private sector increased rates have been in effect for some months and we would propose to increase our rates to the minimum rates charged by the private sector.

For the information of Council we would add that our on going cost reports indicate that the commercial container costs are less than the revenue. These costs and revenues will be shown in the Municipal Treasurer's Annual Report to Council.

The present rates are as follows:
