## RECOMMENDATION:

## REPORT

At its meeting of 1979 July 16, Council received Supplementary Items Nos. 25, 26 and 27 on the above subject and tabled both items until the meeting of 1979 July 30.

The Parks and Recreation Commission by telephone poll on 1979 July 26 approved a recommendation - "THAT the kiln building be demolished by Bestwood Industries Limited in accordance with the conditions of their lease".

This decision was based upon additional information supplied by the Deputy Chief Building Inspector which pointed out the poor condition of the building including the fact that the cement block walls contained no reinforcing steel and the concrete on the slab roof was beginning to crumble. Following a review of these and several other negative factors, the Commission concluded that it would be inappropriate to retain the building.

Only the following minor buildings will therefore be temporarily retained on the site:-

- a. Office building
- b. Metal storage building immediately adjacent to the railway tracks.
- c. Timekeeper's and Superintendent's offices and washrooms.
- d. Barge tie-up structure and dolphins (not including the building adjacent to the tie-up structure).
