The following is the substance of Mrs. Chan's address:

"In March of this year we purchased the property at 5510 East Georgia Street. At the time of purchase, when dealing with the original owner and the Real Estate Agent, we asked about having the suites put into

the premises. Both these individuals assured us that it would be perfectly alright to construct the suites as we requested. The only stipulation was that they would be classified as In-law Suites. We had an agreement drawn up and the contractor was supposed to satisfy all Municipal and Federal Building Regulations. As these were professional people we were dealing with, we thought that they would be aware of the requirements of the By-law. As a result of this, we went ahead and purchased the property. The Municipality has now contacted us and advised both suites have to be removed. We are appealing to you, as we entered into this agreement honestly and sincerely, to give us relief from the By-law. The contractor and the agent mislead us into purchasing the property and now the contractor has written us a letter saying simply that he will remove the kitchen facilities, and that is as far as his responsibility goes in this matter. This is definitely an in-law suite as it is occupied by my family, my mother and father-in-law, and also my brother-in-law and his wife and children. The one kitchen is on the top level and it is impossible for us all to use that one facility. Again, we are just asking for relief from the By-law, as we did not error intentionally. We are asking that at least one of the additional kitchens be allowed to remain.

Alderman Lewarne referred to an article that appeared in the Vancouver Sun Newspaper on 1979 August 31 concerning a decision by the Vancouver City Council to limit the number of self-service gasoline stations that may be permitted within the City. Alderman Lewarne read a statement that was encompassed in the article that appeared in the newspaper to the effect that "Gulf Oil Company lawyer, Don McKinley, had asked whether the Company should go ahead with its court challenge of the City's right to limit the number of self-service stations". Alderman Lewarne questioned as to whether Burnaby would have staff attend the court challenge of the City's rights with respect to this matter to be heard on 1979 September 27.

The matter was left in the hands of staff as to whether there would be some merit in attending the court.

Alderman Lawson

Alderman Lawson questioned the Municipal Engineer as to whether or not there were current studies being conducted at the Canada Way and Burris intersection with regards to the number of right and left turns being made during rush hours.

In response to Alderman Lawson's question, the Municipal Engineer advised that the matter of what to do at the Canada Way and Burris intersection is under the complete control of the Department of Highways, and though he would not answer specifically as to whether those traffic movements are currently being monitored, he would expect this may be the case. The Municipal Engineer stated that he would confirm the fact of whether or not a study was currently taking place.

WHEREAS there have been numerous complaints and considerable unrest in the North-west corner of the District of Burnaby resulting from:

- a) Commuter traffic and non-local traffic using the residential streets in that sector as through commuter-type routes to connect to Cassiar Street;
- b) Visitors to Pacific National Exhibition events using the residential streets as parking lots and access routes; and

WHEREAS other cities (i.e. Edmonton) have proven that the need for transportation to stadium events can be properly met by revamped transit schedules and special buses, thereby eliminating parking requirements on streets near the stadium and reducing traffic movement in the area - the Cassiar Street traffic volume is a problem which, through feeder streets, involves Burnaby with the involvement being indirect but a problem nevertheless; and

WHEREAS to deal with beforenoted items (a) and (b) will require the co-operation of and a bona fide commitment from each of the City of Vancouver, the Province of British Columbia (Ministry of Transportation, Communications and Highways), the Federal Government: (Highways Department with respect to the Trans Canada Highway as it joins Cassiar Street), the Pacific National Exhibition and the District of Burnaby - an additional partner to the solution of the noted problem will be the transit body which succeeds British Columbia Hydro and Power Authority;

THEREFORE BE IT RESOLVED THAT the District of Burnaby formally recommend to the beforenoted entitles;

- 1. THAT for stadium events:
 - Parking on residential streets be eliminated for a two (2) to three
 (3) mile radius (or such distance as may be found necessary) around the Pacific National Exhibition grounds;
 - b) Special buses and other transportation services be arranged by a cooperative effort of the Pacific National Exhibition and transit people to transport people from surrounding areas to the events.
- 2. THAT with respect to the Cassiar-Freeway traffic and the Cassiar-Hastings intersection:
 - (i) Access to Cassiar Street from streets running East-West, connecting from the East to Cassiar Street, be eliminated or restricted;
 - (11) Cassiar Street be designated a limited access route with the prime purpose of connecting the Freeway to the Second Narrows Bridge;
 - (iii) That Access to Cassiar Street at Hastings Street be eliminated and street patterns be modified in the area up to three (3) or four (4) miles from the intersection to permit traffic to enter the Freeway-Cassiar-Second Narrows Bridge route at other points not in solid residential sectors;
 - (iv) That the lands abutting Cassiar Street to the West be consolidated with Cassiar Street and used to provide space for a widened or realigned Cassiar Street with a buffer zone to protect residences on the East of Cassiar Street;
 - (v) That Cassiar Street be reconstructed to pass beneath Hastings Street and the grade of Hastings Street remain unchanged with no clover-leaf exchange; (see (iii) above which indicates that the access to the Freeway-Cassiar-Second Narrows Bridge route will be from points some distance from Hastings Street);
 - (vi) That the Pacific National Exhibition alter its access to Cassiar Street where required;
 - (vii) That, where necessary for changes to Cassiar Street, certain residential properties be acquired at fair compensation."
