The reasons are because the house is in excess of thirty years old, and because of its height, the relocation to another site would in all likelihood require the removal of the top floor to eliminate interference with overhead wires.

Pursuant to Item #1, a Notice to Vacate was served on the tenant and we have now been lucky enough to have found him other accommodation and he will be vacating 9489 Cameron Street on 1979 March 02.

Pursuant to Item #2, due to an oversight, this house has not been advertised for sale. This creates a problem in that it will take at least six weeks to have the residence advertised for sale and removal and the fact that the tenders for the construction of the Library have already been called thereby creating a need for the building to be removed from the site at the earliest possible moment.

There is one other factor involved in that this residence is 33 years old which conflicts with the Municipal Building By-Law 1973 No. 6333 on removal of buildings to another site in the Municipality.

We feel therefore, that if this construction is to commence on time, that Council approve the demolition of the residence at 9489 Cameron Street as soon as possible.

#### REPORT

The Project Coordinator for the Northeast Burnaby Library/Recreation Complex on Cameron Street has been advised by the architect that construction of the project will commence 1979 March Ol. It is understood from the Acting Land Agent that one hundred and twenty (120) days notice to vacate is to be given to the tenant.
