 THAT the lowest tender to meet the Municipal Specifications, submitted by Reid, Collins Nurseries Limited in the amount of \$67,240.80, with a 2% discount for prompt payment, be accepted.

REPORT

Tenders for this contract were received up to 1500 h local time on Tuesday, 1979 September 18.

The tender calls for the supply and delivery of 1208 street trees to the Oakalla Prison holding nursery; 468 to be used in the Willingdon Heights N.I.P. Program and 740 trees to be used in the 1979 Local Improvement Program.

Three (3) tenders were received and opened in the presence of Messrs. R. Constable, J. Hagen and representatives of the firms bidding.

A tabulation of the tenders received is attached.

The tender from Reid, Collins Nurseries Limited complies with our specifications regarding size, species, warranty and a thirty-day delivery, whereas, the lower tender submitted by Pacific Coast Nurseries Limited is based upon smaller caliper trees than specified, does not accept liability for the trees as required and has a delivery date of 1980 May/June. We would, therefore, recommend that the contract be awarded to Reid, Collins Nurseries Limited.

The Parks Administrator concurs with this recommendation.
