#### REPORT

The present contract for vending machines is held by Vancouver Enterprises Ltd. and expires 1979 October 14.

Tenders were called for the supply and installation of vending machines for a period of two years in the following locations:

C.G. Brown Memorial Pool Bonsor Park Pool Burnaby Lake Rink Kensington Park Rink Kensington Pitch and Putt Central Park Pitch and Putt James Cowan Theatre

A tabulation of the tenders received is attached.

Based on the 1978 gross vending sales as reported by the auditors of Vancouver Enterprises Ltd., the Treasury Department have estimated the anticipated Corporation commission on the various tenders, excluding Alta West Industries whose proposal was obviously inferior to the other tenders. The following is a summary of these estimated commissions:
