REPORT

On the agenda there is a letter from Svend J. Robinson, M.P. regarding the Federal Government Community Services Contribution Program.

The attachments to Mr. Robinson's letter indicate that of the 229 projects approved to date throughout the Province, all were for water and sewer works.

Burnaby made four grant applications under this program:

REPORT

Tenders were invited up to 15:00h local time on Tuesday, 1980 November 18th for the supply and delivery of the subject trucks.

In addition to our usual advertisements in the Journal of Commerce and the Vancouver Sun, tender documents were mailed to six (6) possible Suppliers.

The tenders were opened in the presence of Messrs. Constable, Hagen and representatives of the firms bidding.

A tabulation of the tenders received is attached.

Funds have been provided in the 1980 Capital Budget for the purchase of this equipment.

At present we have two (2) 1979 Model White Trucks complete with Dempster Bodies in service and they have proven to be very satisfactory.

The Municipal Engineer concurs with the recommendation.
