Recommendation:

1. THAT Council authorize the granting of a contract to E.J. Murray and Son Wholesale Nurseries Ltd. in the amount of \$16,649.88 for the supply and delivery of plant material required for the landscaping of Eastburn Community Centre and Cameron Library and Recreation Centre.

REPORT

Tenders for the supply and delivery of a total of 4,196 trees, shrubs and ground cover plants to be used for the landscaping of Eastburn Community Centre and Cameron Library and Recreation Centre were called and although well-advertised, only two tenders were received. A tabulation of these is attached.

The tender prices quoted by E.J. Murray and Son Wholesale Nurseries Ltd. (\$16,649.88) and Massot Nurseries Ltd. (\$18,608.20) are both well below the estimated cost of \$26,318.60. The major reason for the low prices is the large quantity of plants being ordered and some size substitutions which are insignificant. Both tenders quote prices that are significantly lower than catalogue prices.
