RE: TENDERS FOR HALF-TON MINI PICK-UP TYPE TRUCKS

Following is a report from the Purchasing Agent regarding tenders for equipment.

The Purchasing Agent on the basis of instructions received from the Engineering Department initially called tenders for four mini pick-up trucks and two cars. A subsequent review of requirements disclosed that the operational effectiveness of the department would be better served if all vehicles were trucks. The Purchasing Agent was then requested , following the date on which tenders closed, to adjust the requirements from four trucks and two cars to six trucks.

 THAT Council approve the issuance of a purchase order to White Spot Service Limited to supply six (6) 1980 Model Datsun King Cab Trucks, as specified, for the sum of \$41,121.60 including applicable taxes.

REPORT

Tenders were invited for the supply and delivery of four (4) - Half Ton Mini Pick-up Type Trucks complete with automatic transmissions and two (2) Compact Automobiles for use in the Engineering Department.

In addition to regular advertisement in the Vancouver Sun and Journal of Commerce, tender documents were mailed to a number of possible suppliers.

A tabulation of the tenders received is attached.

Provision for the purchase of six (6) mini trucks is included in the 1979 Capital Budget.

The lowest tender was submitted by Eagle Ford Sales Limited, they offered to supply 1980 Model Ford Pinto Panel/Delivery Trucks. This type of vehicle certainly departs from our specifications, however, staff from the Engineering Department have carefully examined them and have concluded that they are not satisfactory for our use.

The second lowest tender was submitted by Westminster Chevrolet Oldsmobile, offering to supply 1980 Model Chevrolet CC 10703 Trucks. This is a <u>full</u> sized truck which, of course, fails to satisfy our specifications and from an operating cost point of view is not considered practical for our type of operation.

Casey Dean Lincoln Mercury Sales Limited closed for business soon after submitting their bid, therefore, no consideration was given to the Ford Courier.
