Re: Transportation Matters

1. Comprehensive Transportation Plan for Burnaby

Recommendation:

"That Council reconsider their motion to terminate the Transportation Committee in view of the fact that Council on 1979 April 09 adopted in principle the booklet entitled 'Transportation Policies for Burnaby' in which policy Item 14 - 'Role of a Transportation Committee' reads as follows:

'That Council assign an ongoing responsibility to a Transportation Committee comprised of members of Council, representatives from the various sectors of the community and staff to prepare, sponsor and implement transportation related improvement proposals and programs for the consideration of Council.'

R E P O R T

Council, on 1980 July 21 received the report of the Transportation Committee entitled "Comprehensive Transportation Plan Implementation Strategy/Schedule Review" and adopted the following motion:

"That following the Transportation Committee's consideration of the alignment, jurisdiction and scheduling of the Marine Way/Tenth Avenue Connector, the Committee be requested to submit a final report on its activities to the Municipal Council."

Your Committee is of the opinion that an ongoing Transportation Committee is a necessity to consider any changes to the Comprehensive Transportation Plan for Burnaby as well as providing a forum for Burnaby citizens to voice their concerns regarding major transportation issues as they arise.
