RECOMMENDATION:

1. THAT Mr. U'Ren be granted permission to hold their requested street dance on 7400 Block Holly Street subject to the conditions contained within this report.

REPORT

Reference the submission from Mr. Stuart J. U'Ren of 7434 Holly Street requesting permission to hold a street dance on the captioned section of Holly Street on the afternoon and early evening of Saturday, 80 07 26.

This request is similar to that received from Mr. U'Ren for a dance in the same location last year. Permission was granted for this previous request subject to the conditions stated below. As we did not receive any adverse reports from the previous event we do not anticipate any problems with this year's event. The 7400 Block Holly Street could be closed to traffic without any vehicular disruption to area residents. However the following conditions must be complied with:

1. That the preparation, storage and serving of foods be in accordance with Provincial Health regulations (a copy can be obtained from the Burnaby Health Department).
2. That the applicants advise the managers of the two apartments addressed 7110 and 7150 Fulton Avenue of the intended street dance.
3. That the applicants advise the occupants of 7426, 7438, and 7424 Holly Street and 7115 Humphries Avenue of the intended street dance.


