(a) Mr. B.H. Buchannon then addressed Council on the subject of the installation of a traffic signal at Holdom Avenue and Parker Street.

Mr. Buchannon advised Council that he was adamantly opposed to the installation of a traffic signal at Holdom Avenue and Parker Street, together with the planned widening of the Parker Street approaches to Mr. Buchannon was of the opinion that the instalthe intersection. lation of a traffic signal at this point would add even more traffic to the 17,000 vehicle per day volume that exists at this time. Mr. Buchannon's opinion that the installation of the traffic signal would make a complete disaster in this particular area. The existing four way stop sign control at this intersection provides adequate safety for the traffic using the intersection. There have been very few motor vehicle accidents at the intersection and those that have occurred are of a minor nature. Mr. Buchannon reiterated his belief that the installation of this traffic signal and the accompanying widening of Parker Street would make access on to Parker Street almost impossible for those residents living adjacent to the proposed widening.

His Worship, Mayor Mercier, entered the Council Chamber and assumed his position as Chairman of the Council Meeting at 19:07 h.

Alderman W.A. Lewarne entered the Council Chamber and took his place at the Council Table at $19:07\ h.$

Mayor Mercier explained to the Council Meeting that he and Alderman Lewarne, accompanied by the Municipal Manager, had just returned from Victoria at a meeting with the Minister of Transportation and Highways. Mayor Mercier indicated that he would submit a verbal report on this meeting later in the evening.

Alderman Drummond suggested that Council obtain up-to-date traffic counts for the intersection of Holdom Avenue and Parker Streets, particularly in the rush hours, 07:00~h to 09:00~h and 16:00~h to 18:00~h.

MOVED BY ALDERMAN BROWN: SECONDED BY ALDERMAN DRUMMOND:

"THAT no work be done to this intersection until the information requested by Alderman Drummond regarding traffic counts in the morning and evening rush hours is received by Council."

(b) Claire Bennett then addressed Council on the subject of Local Improvement Project No. 79-032, McKay Avenue - Greta Street to Rumble Street.

Ms. Bennett noted that since appearing before Council in connection with this same subject on 1980 September 29 she had been meeting with most of the affected property owners. At that meeting in September there were fifteen property owners opposed to the project and nine in favour. the last two months several owners have re-thought their previous decision and this represents a significant reversal. We now have eleven property owners opposed to the project and fifteen property owners in support. That is out of a total of twenty-six properties. Ms. Bennett drew to Council's attention that Project No. 79-032 was initiated as a result of citizens' requests. The property owners who now support the project would like to make a change in the program, and that is to delete the proposed trees. The street is already well treed and we have a very nice Ms. Bennet submitted that this reversal in numbers warranted Council's reconsideration of the project. The deletion of the trees constitutes a variation of the original proposal and for that reason it was requested that the one year waiting period to reinitiate the project be waived.

(c) Mr. Joe J. Bayer then addressed Council on the subject of Local Improvement Project No. 79-032. Mr. Bayer reviewed in detail his submission to Council on this subject on 1980 September 15. He noted that as a result of his submission at that time that Council had decided that Local Improvement Project No. 79-032 would not be proceeded with. Mr. Bayer was of the opinion that Council had made the correct decision at that time and urged that Council reiterate its previous decision not to proceed with this work. Mr. Bayer advised that he could not concur with the figures presented by Ms. Bennett with respect to the number of abutting owners that are now allegedly in favour of the project proceeding. Mr. Bayer suggested that Council had made the correct decision in September not to proceed with the work and he urged that Council take no action to change its previous decision.

His Worship, Mayor Mercier, advised Council that he, together with Alderman Lewarne and the Municipal Manager had met with the Minister of Transportation and Highways for approximately one hour this afternoon. The Minister indicated that he is supporting the funding for the B.N.R. Overpass as the first of a series of items in the Comprehensive Transportation Study. The Minister also confirmed his agreement with the total Comprehensive Transportation Plan and the basis for implementing it. It was a totally satisfactory meeting. The amount that will be going into the B.N.R. Overpass will be in the neighbourhood of $\$3\ \mbox{million}$ to $\$3\frac{1}{2}\ \mbox{million}$ from the Provincial Government.

The Minister also made it clear that the Annacis Crossing will contain provision for expansion to accommodate transit, which could be buses, rail, or whatever.

His Worship advised Council that additional details of the meeting with the Minister of Highways would be available for discussion at a later time.

Owens outlining Council's area of responsibility and advising that the authority for this item rests entirely with the Burnaby School Board, and that a copy of Council's reply to Mr. Owens, together with a copy of Mr. Owens' letter, be forwarded to the Burnaby School Board."

(e) Province of British Columbia, Ministry

 Re: 8th Installment - 1980 Unconditional Grant

A letter dated 1980 November 17 was received enclosing a Province of British Columbia cheque in the amount of \$922,900.00 which represents payment to the Municipality of Burnaby of the eighth installment of the 1980 Unconditional Grant pursuant to Part VIII of the Revenue Sharing Act Regulations.

(f) Lower Mainland Municipal Association, Secretary-Treasurer Re: Proposed Planning Act

A letter dated 1980 November 12 was received requesting that any comments which this municipality might have on the new "Planning Act" be forwarded to the Secretary-Treasurer, Lower Mainland Municipal Association, prior to 1980 December 15. A special Committee of the Association will summarize the submissions and report to the next meeting of the Association in February.

(g) Province of British Columbia, Ministry of Finance Re: 1981 Property Assessment

A letter dated 1980 November 17 was received advising that recent analysis of the 1981 actual value projections based on sales evidence compiled for the third quarter of 1980 has revealed that the reduction in percentage of actual value from 14.5 to 13.0 percent applied to residential type properties under Order-in-Council 2186/80 will not prevent a substantial Tax share shift to residential properties from occurring in 1981.

Identification of this problem, however, has brought with it no simple solution since, in the prevailing economic climate in British Columbia, the value of property will undoubtedly continue to rise. This is particularly true of residential property in all areas of the province, although the rate of increase varies from region to region. The remedy, therefore, to this unacceptable situation appears to lie in Provincial Government action.

For this reason, the Minister plans to recommend to Cabinet a further reduction in the percentage of actual value to be used in 1981 for Class 1 and Class 8 properties from 13 percent. The exact percentage is to be announced when more precise projections of 1981 actual values become available later this month.

The Minister was advising his plans at this time so that Council can consider the effect of the reduction when it advises the Assessment Commissioner of the Option under which assessments in this municipality are to be determined for general municipal taxation purposes in 1981 in accordance with the requirements of Section 26(19) of the Assessment Act.

Items 15 and 23, Municipal Manager's Report No. 72, 1980 November 24, pertaining to this subject, were brought forward for consideration at this time.

The Municipal Manager provided a report from the Municipal Treasurer regarding the 1981 property assessment. The Municipal Treasurer reported that in 1977 Council, by bylaw, adopted Option A as its assessment base. It amounts to adopting for general municipal purposes the same assessment roll as that used for school and hospital purposes. The option remains in force until such time as the bylaw is amended to select another option.

Council on 1980 October 20 received a copy of the Assessment Option Studies. These studies showed that the residential classification would pay more of the tax load in 1980 than in 1981, to the benefit of other classifications. This trend was prevalent throughout the province. To remedy this situation the Minister is recommending a reduction in the percentage of residential assessments taxed.

When the exact percentage is announced and more precise projections for 1981 actual values become available, a further report will be submitted to Council. Meanwhile, there is no evidence that any change in assessment options should take place at this time.

The Municipal Manager recommended:



Additional information on the effect of P.C.B. contamination on the Fraser River sediment near the Belkin outfall has been requested from Environment Canada, Environmental Protection Service. A further report will be submitted to Council upon receipt of this information.

In the event that existing improvements on the site are vacant and considered to be a hazard to life or property, the Fire Prevention Office may issue an order to demolish such improvements and remove the resultant debris prior to Third Reading.
 - (f) The granting of any necessary easements.
 - (g) The dedication of any rights-of-way deemed requisite.
 - (h) The retention of as many existing mature trees as possible on the site.

 - (j) All applicable condominium guidelines as adopted by Council shall be adhered to by the applicant.
