Mrs. Christine F. McGrath then addressed Council on the subject of the barricade at Haszard Street and Canada Way. The following is the text of Mrs. McGrath's submission:

"In regard to the barricade at Haszard Street and Canada Way I strongly urge that it be retained for the following reasons:

The safety of Haszard Street has long been the source of concern to the residents who in the past had requested the closure of the street at Canada Way with 100% support. Before the installation of the barricades the majority of the residents avoided access and egress to Canada Way at Haszard Street because of the danger at this intersection due to restricted visibility and inappropriate alignment of Canada Way – facts supported by a formidable history of traffic mishaps and fatalities at this section of Canada Way.

The use of this street by non residents has resulted in several incidents of property damage — our fence has been hit on several occasions and a neighbour's hedge was partially destroyed by a car out of control. In these incidents we have been fortunate in that none of our children have been injured. Haszard Street is dangerous because it is narrow, has an obstruction to visibility in the rise at the entrance from Canada Way and also at the north side of the intersection with Gordon Street in addition to the limited visibility and dangerous alignment at the intersection with Buckingham Avenue.

This corner is particularly dangerous for children from the area en route to and from school and increased traffic on Haszard Street would almost certainly result in an accident.

With the barricade removed it is inevitable that Canada Way traffic would use it as a time saving alternative to the lights at Burris Street intersection and with drivers unfamiliar with the danger spots, accidents and property damage would result. There are a number of children living on the street and their safety would be jeopardized.

As an alternative egress and access to Canada Way, Haszard Street is totally unsuitable for the volume of traffic it undoubtedly would have to carry. The present suggestion of opening the barricade would be a direct response to the persistent complaints of one particular resident of Canada Way and would result in a very definitely negative affect for the majority of taxpaying residents who have remained a silent, grateful majority. It is hoped that the Council will stand firmly by its progressive decision to improve safety as well as the residential environment rather than remaining bound by old planning mistakes.

The incidents of traffic accidents on Canada Way have been reduced in severity since the barricades were installed and the occasional inconvenience of traffic delays as the result of mishaps is not unique to this highway and can always be relieved by opening the gate at Sperling on such occasions.

The Fire Department has reported that access to the fire hydrant on Haszard Street is not a problem.

Please remain firm on maintaining the barricades. They have greatly enhanced the quality of community life in the neighbourhood and reduced some of the stress of traffic which is already a formidable source of air and noise pollution along Canada Way."

"We, the undersigned, all living within a half-mile radius of the intersection of Imperial Street and Sussex Avenue, consider this intersection to be most dangerous for pedestrians crossing Imperial Street to catch the bus or crossing Imperial Street to shop at the group of seven stores on Imperial Street. The very heavy vehicular traffic on Imperial Street, the buses travelling on Imperial Street and Sussex Avenue, combined with vehicles parked in front of the stores, and off-loading trucks blocking the view of on-coming traffic, make this intersection most hazardous. We submit this petition to the Burnaby Council to request, at the least, a pedestrian crosswalk to cross Imperial Street from the southwest corner of the intersection to the northwest corner."

Item 6, Municipal Manager's Report No. 15, 1980 February 25, pertaining to this subject, was brought forward for consideration at this time.

The following are the recommendations contained in this report:

- (1) THAT Sussex Avenue between Imperial Street and Beresford Street not be centre-lined.

It is the intention of the Housing Committee to review the various policies established by neighbouring municipalities with respect to illegal suites prior to formulating a recommendation for Council's consideration.

The Housing Committee is of the opinion that the Text Amendments to the Residential Occupancy Standards will effectively negate the future construction of non-conforming fourplex dwellings while maintaining the residential occupancy densities as designated in the Burnaby Zoning By-law.

The Housing Committee recommended:

- (1) THAT the Chief Building Inspector be directed to discontinue the houseto-house survey of dwellings suspected of containing a non-conforming suite.
- (2) THAT the Chief Building Inspector continue the investigation of complaints received from Burnaby residents regarding the alleged existence of non-conforming suites within dwelling units.
- (3) THAT the Chief Building Inspector deploy the services of the Housing Inspector to determine the location of all fourplex dwellings located within the Municipality of Burnaby.
- (4) THAT staff be directed to investigate the feasibility of creating a fourplex zone.
- (5) THAT those owners of non-conforming dwelling units who have received notification from the Chief Building Inspector requesting that the dwelling unit be brought to a legally conforming standard, be granted an extension of six months, until 1980 September 01, in order to allow the Housing Committee an opportunity to thoroughly review the matter.

The proposed installation is called a "Naphtha Prefractionator" and consists of a separate column 7 feet 6 inches in diameter by 160 feet in height, two new vessels, and additional heat exchanges and pumps. This facility is proposed to be located in the Rheniformer unit what is known as Area 2, the actual processing area north of Penzance Drive.

The unit covered under this application, while not included in the Chevron Refinery Modernization Program Master Plan approved by Council in 1974, does not represent any increase in refinery capacity, and moreover is in accordance with the provisions of the Burnaby Zoning By-law which apply to this site.

It is, therefore, the Planning Department's intention, unless otherwise directed by Council, to issue Preliminary Plan Approval #5413, subject to satisfaction of all pertinent by-laws and environmental and safety regulations.

- (4) THAT Council request the G.V.R.D. to work with Municipal staff to examine the proposed yard site location and layout with respect to the proposed Byrne/10th Connector, the proposed B.C.H.R. right-of-way realignment, and the appropriateness and impact of this facility in the context of existing and proposed land use development in this area.
- (5) THAT Council request the G.V.R.D. to work with Municipal staff to resolve the other areas of concern regarding alignments and station locations as discussed in this report and outlined in the summary.
- (6) THAT Council authorize Municipal staff, in consultation with the G.V.R.D. to give further consideration to the design, circulation, accessibility and adjacent land uses at the proposed stations in Burnaby.
- (7) THAT Council request the G.V.R.D. to ensure that there is the opportunity for a high degree of Municipal involvement in subsequent design and implementation work that is carried out with regard to LRT routes in Burnaby.

Alderman Randall enquired into the current status of bus shelters at the Lougheed Mall.

The Municipal Engineer replied that the British Columbia Hydro and Power Authority has a working arrangement with the operators of the Lougheed Mall with regard to the operation of the bus terminal at that site. The Municipal Engineer indicated that his department would pass on Alderman Randall's concerns regarding the lack of bus shelters at the Lougheed Mall to the British Columbia Hydro and Power Authority.
