Mr. Lanny Honour, 8483 - 16th Avenue, then addressed Council on the subject of a bus shelter proposed for construction in front of his residence. The following is the substance of Mr. Honour's submission:

"The purpose of this delegation is to show that there is just reason for re-instating the former bus loop at 16th Avenue and Cumberland Street. From our observations, approximately twenty-five percent of the bus users from the George Derby Hospital travel in an easterly direction towards the Lougheed Mall. The balance of the hospital Τf patients travel in a westerly direction towards New Westminster. a patient from the George Derby Hospital wishes to travel towards the Lougheed Mall he must cross the busy intersection of 16th Avenue and Cumberland Street to catch the bus. If a patient travels towards New Westminster the same intersection must be crossed before he can return to the George Derby Hospital. This intersection receives very little respect from automobile traffic. The stop sign for eastbound automobile traffic is virtually ignored. The Municipal Engineer has stated in his report that there are 175 potential bus users from the George Derby Hospital. I stand by our previous statement, that these elderly hospital patients have to challenge the automobile to cross the intersection of 16th Avenue and Cumberland Street. It is very probable that it is only a matter of time before one of these elderly gentlemen falls victim to the automobile in this intersection. A possible Re-instate the bus solution to this problem is as we have suggested. loop that was previously located at the northeast corner of 16th Avenue and Cumberland Street. If buses from both directions use this loop, one bus shelter located in this loop would provide the needs of the east and west bus travellers and none of the 175 potential east and west bus riders from the hospital would have to cross the intersection for the purpose of bus travel. We feel that this is a reasonable solution for the following reasons:

- It fulfills the needs of the residents of the George Derby Hospital wishing to use the transit system.
- (2) A bus shelter located within this suggested loop would not detract from the residential section of the neighbourhood.
- (3) The traffic turning in the intersection would no longer be hampered by the buses stopping to pick up passengers.
- (4) One bus shelter would provide for both east and west bus users.

If this suggestion does not meet with approval, we again ask that the decision to locate a structure of this design and physical size on our frontage be reconsidered."

Mr. Horsfield stressed that he is very satisfied with his accommodation and does not intend to move unless those concerned obtain other suitable accommodation for him at reasonable rental rates.

The Municipal Manager provided a report from the Chief Building Inspector arising out of the correspondence received from Mr. Richard Horsfield.

The Chief Building Inspector reported that the subject premises were inspected in 1979 January during the Residential Occupancy Standards Survey being conducted by the municipality and were found to be occupied by more than the authorized two separate families. Letters to the owner, Mrs. Gay Soutter, received no response and on 1979 September 20, the matter was referred to the Provincial Prosecutor.

From September 1979 to July 1980 there were nine adjournments of Court proceedings. On the tenth appearance in Court on 1980 July 16, Mrs. Soutter was found guilty of violation of Burnaby Zoning Bylaw No. 4742, Section 105.1, and fined \$100.00 to be paid by 1980 September 15.

A letter dated 1980 October 15 was received enclosing a Province of British Columbia cheque in the amount of \$500.00, which represents the Ministry's current contribution towards the staff position of Sports Co-ordinator.

The Minister noted that this program has helped establish two hundred and twenty-four staff positions in the Province since 1971 April. The Ministry is now looking at ways in which it can help the municipality to upgrade and develop the staff it already has.

However, since this solution would involve other governments it is difficult for the Committee to assess the possibility of it being implemented. The Committee requested, therefore, that Council investigate the feasibility of this closure and inform the Committee of its conclusions.
