REPORT OF THE POLLUTION COMMITTEE

1. 2338 Gilmore Avenue

(FILE: 1644)

Recommendation:

1. "THAT the Municipal Engineer be authorized to obtain cost estimates and arrange to connect the premises to the sewer, assuming a reasonable cost estimate is obtained for the hook up.
2. THAT the costs for this hook up be included with the property taxes if not paid upon invoicing as provided in By-law Number 4247, Section 13."

R E P O R T

The Municipal Engineer reported that the owner of the property at 2338 Gilmore Avenue has received a registered 60-day notice requesting connection of the property to the Municipal Sanitary Sewer as required in By-law Number 4247, Section 3(1).

The owner, on 1979 June 12, obtained a permit from the Municipal Engineering Department to connect the premises to the sewer, however, to date no work has transpired and the permit has since expired.

The Municipal Engineer requests permission to obtain estimates and arrange to connect the properties to the sewer with the charges to be added to the property taxes if not paid upon invoicing as provided in By-law Number 4247, Section 13.

2. 6650 Deer Lake Drive

(FILE: 1644)

Recommendation:

1. "THAT the Municipal Engineer be authorized to obtain cost estimates and arrange to connect the premises to the sewer, assuming a reasonable cost estimate is obtained for the hook up.
2. THAT the cost for this hook up be included with the property taxes if not paid upon invoicing as provided in By-law Number 4247, Section 13."

R E P O R T

The Municipal Engineer advised that the owner of the property at 6650 Deer Lake Drive has received a registered 60-day notice requesting connection of the property to the Municipal Sanitary Sewer as required in By-law Number 4247, Section 3(1).

On 1979 September 24, a registered notice was sent to the owner of 6650 Deer Lake Drive. However, to date no reply has been received.

The Municipal Engineer requests permission to obtain estimates and arrange to connect the properties to the sewer with the charges to be added to the property taxes if not paid upon invoicing as provided in By-law Number 4247, Section 13.

3. Alternate Means of Gargage Disposal (FILE: 1745)

Recommendation:

"THAT this report be received for information purposes."

R E P O R T

The Pollution Committee met on 1980 January 24 to consider the notice of motion regarding "Alternate Means of Garbage Disposal" as adopted by Council on 1980 January 07.

Arising out of the Council's deliberations on this subject, the following motions were adopted, namely:

1. "THAT this item be referred to the Pollution Committee to come up with guidelines as to how this \$50,000.00 can be expended.
2. THAT the Pollution Committee hold a meeting with the representative of the Greater Vancouver Regional District who is conducting a similar study and at that time staff bring forward a report as to what other government funds might be available and that all Members of Council be invited to attend this meeting."

With respect to recommendation 1, the Pollution Committee is of the opinion that this money may best be utilized by obtaining a consultant to provide input into the Committee's review and also cover travel expenses for the Committee and staff to view sites where alternate means of garbage disposal have been implemented.

The Committee has tentatively agreed to view the incinerator site in operation at Bellingham, Washington after the meeting with Greater Vancouver Regional District representatives.

With respect to recommendation 2, the Pollution Committee wishes to advise that a meeting has been arranged with Mr. T. Ellis, Project Manager and Mr. W. Mechler, Senior Assistant Engineer, Greater Vancouver Regional District, for Thursday, 1980 February 07, in the Council Chamber, Municipal Hall at 16:00 h.

The purpose of this meeting is to review terms of reference for the study which the Greater Vancouver Regional District is conducting regarding alternate means of garbage disposal.

All Members of Council are cordially invited to attend the meeting with the Greater Vancouver Regional District representatives on Thursday, 1980 February 07.
