RECOMMENDATIONS:

1. THAT Council approve the awarding of the contract for the refurbishing of Swangard Stadium track to Standard General Construction (B.C.) Limited for the Sportflex Super X surface at a cost of \$326,900.00.
2. THAT Council approve the execution of the necessary contract documents.

REPORT

At its meeting of 1980 July 07, Council received an information report, Item 20 of Manager's Report No:46 on Swangard Stadium track advising that the Corporation was in receipt of a grant from the Provincial Government in the amount of \$300,000.00 which together with the Corporation's funds already budgeted would be sufficient to refurbish the Swangard track.

The tenders for the track resurfacing have been received and were opened in the presence of staff and two representatives from B.C. Track and Field.

The attached 'Tabulation of Tenders' lists the four tenders received. These tenders have been analyzed and evaluated in relation to our specified requirements and existing budget for the track. The budget remaining for the project is \$328,500.00, therefore the low tender is within our budget capability.


