(a) Mr. Stanley J. Wales, President, Wales McLelland Development Company Limited, then addressed Council on the subject of the Royal Oak Funeral Home and its designation as a heritage site.

Mr. Wales advised Council that he was here this evening to determine if the site in question was to be declared a heritage site or not. If the structure is to be considered a heritage site his company would have no interest in the further development of the site. Wales McLelland Development Company is prepared to develop under the existing zoning. They are not, however, prepared to develop under Comprehensive Development and retain the building as a heritage site. Mr. Wales was of the opinion that this would be financial suicide. Mr. Wales advised that his company would be more than willing to donate the building to the municipality if it was possible to remove the house from the site.

## MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN STUSIAK:

(b) Mrs. Mary Nystrom then addressed Council on the subject of housekeeping rooms at 7067 17th Avenue, Burnaby, B.C.

Mrs. Nystrom advised that she and her husband had purchased the property at 7067 17th Avenue in 1973. It is located on a sixty-six foot lot and has not been added to or altered since the date of purchase. On 1980 April 14 notice was received from the Chief Building Inspector requesting that the tenants living in the basement of the structure be given notice to vacate on 1980 May 01. Four out of the five of these tenants have not been able to find alternative accommodation and are still resident on the premises. Mrs. Nystrom requested that Council set aside the eviction notice issued by the Chief Building Inspector to permit her tenants to

remain in their present accommodation. Mr. Nystrom also requested Council's permission to install an electric stove in the basement of the structure.

### MOVED BY ALDERMAN AST: SECONDED BY ALDERMAN BROWN:

"THAT this matter be referred to the Chief Building Inspector for a report as to the legal status of lodgers, boarders, etc., and that the Chief Building Inspector be requested to comment as to whether the situation at 7067 17th Avenue could be construed as a legal non-conforming situation."

#### CARRIED UNANIMOUSLY

(c) Mr. Herbert R. Karras, Burnaby Fish and Game Club, then addressed Council on the subject of the lease of the club premises on the Barnet Highway from Simon Fraser University.

Mr. Karras advised that the Burnaby Fish and Game Club was a registered non-profit association which provided a most important contribution to the recreational opportunities to residents of the Lower Mainland through the use of their facilities on Barnet Road. All facilities are provided at no cost to the municipality and the Burnaby Fish and Game Club pays municipal taxes on their lands, which are leased from Simon Fraser University. The club's facilities are used extensively in the training of all types of peace officers in British Columbia. Mr. Karras further noted that as a result of recent noise tests taken by the Burnaby Health Department at the rifle ranges, it had been shown that the noise generated by the gun clubs was well within the allowable limits set forth in the Noise Abatement By-law. Mr. Karras further advised that to the best of his knowledge no complaints had ever been received concerning the operation of the gun clubs on the Barnet Highway. Mr. Karras advised that he was not aware that Simon Fraser University wished to terminate the lease, but was contemplating this action at the request of the municipality. Mr. Karras went on to say that the one year lease proposed in the Municipal Manager's Report which is before Council this evening was not sufficient to permit the club to carry out proper planning, and suggested that a five year lease with an option to review would be much more viable.

A vote was then taken on the motion as moved by Alderman Emmott and seconded by Alderman Ast, "That Council recommend to Simon Fraser University that they provide a renewable two year lease to the Rifle and Revolver Clubs, subject to the Mayor taking the initiative to bring the parties together, and pending further negotiations and discussions between the Parks and Recreation Commission, staff and the gun clubs", and same was CARRIED with Aldermen Ast and Drummond opposed.

A vote was then taken on the original motion as moved by Alderman Ast, seconded by Alderman Lawson, "That the recommendations of the Municipal Manager be adopted", as amended, and same was CARRIED with Aldermen Ast and Drummond opposed.

(d) Mr. Ed Wood then addressed Council on the subject of the proposed parking restrictions on Hastings Street during the afternoon rush hours, 16:00 h to 18:00 h.

Mr. Wood advised that he and his fellow businessmen on Hastings Street were adamantly opposed to the proposed parking restrictions. If the proposed restrictions are put into effect it is doubtful if the businesses can survive. In his own case, Mr. Wood was of the opinion that he would lose at least fifty percent of his business if there was no parking allowed in front of his store at 4020 East Hastings Street during the two hours in question. Mr. Wood was also of the opinion that the parking restrictions would greatly increase the accident potential on Hastings Street. Mr. Wood further considered that the parking restrictions would not appreciably affect the volumes of traffic that can be handled on Hastings Street at the present time.



# MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN LEWARNE:

"THAT Council do now resolve itself into a Committee of the Whole."



His Worship, Mayor Mercier, presented a report concerning the proposed restructuring of the Advisory Planning Commission.

His Worship, Mayor Mercier, recommended:

- (1) THAT the Municipal Solicitor prepare draft amendments to the said by-law to give effect to the following:
  - (a) The members of the Commission be increased from nine to eleven to accommodate the appointments noted later in this report. Selection process to be handled through Mayor's Office and appointments made by Council following the procedures in place for other Committee and Commission appointments.
  - (b) That area representation be achieved by having six appointees selected, one from each of the six areas outlined in the map attached to this report which was taken from various alternatives submitted by the Director of Planning.
  - (c) There be no ex officio members but such staff members as may be required or requested by the Commission to attend meeting be authorized to do so.
  - (d) That the other five members of the Commission be appointed as follows:
    - 2 from the community at large
    - 1 from Council (Planning Liaison Alderman)
    - 1 from Parks and Recreation Commission (not an Alderman)
    - 1 from Burnaby School Board
  - (e) That all members be entitled to one vote each except that, while the six area representatives may discuss every issue, each of those members will not be entitled to vote on matters arising solely within the boundaries of the area that a member represents.
  - (f) That each item referred by Council to Public Hearing be at the same time referred to the Advisory Planning Commission for consideration of land use policy solely.
  - (g) That pursuant to (f) the Advisory Planning Commission have regular meetings to consider such matters and delegate the Chairman of the Committee, or alternate, at the option of the Commission, to address in writing or in person the Council at the Public Hearing at which each of the matters referred to in (f) are to be heard. The restriction in (e) above would apply for (g) also.
  - (h) Document the policy and/or procedure for inviting delegations to attend, and/or for dealing with requests to be heard, at Advisory Planning Commission meetings, while retaining the existing general policy or otherwise not having "open" meetings.
  - (i) Document the policy and/or procedure for the Advisory Planning Commission to approach Council, for instance, through the Mayor's Office, with subsequent approach to Council, with matters of concern to them, the objective being to provide a recognized avenue for communication.
  - (j) That the Commission consider a policy for holding and/or attending public meetings regarding planning matters at various locations in the community supplemental to and not in place of such meetings as Council may wish to hold. The Commission would request approval of Council before proceeding to arrange such meetings or may do so at the request of Council. The purpose of the meetings would be to assist the Advisory Planning Commission in its deliberations.

(aa) Mayor D.M. Mercier

Re: Proposal for "Burnaby Terry Fox Cancer Research Fund"

His Worship, Mayor Mercier, submitted a report on a proposal for "Burnaby Terry Fox Cancer Research Fund".

In recognition of this exceptional and valiant man and in co-operation with the Area Co-ordinator for the Canadian Cancer Society, His Worship, Mayor Mercier, recommended that:

- 1. Council sponsor the "Burnaby Terry Fox Cancer Research Fund" with the address c/o the Burnaby Municipal Hall.
- 2. A trust bank account be opened in that name to receive donations.
- 3. The Mayor, together with a member of Council or the Municipal Treasurer be the authorized signatories for the trust bank account.
- 4. The proceeds of the trust fund to be paid to the Canadian Cancer Society specifically for research in the name of Terry Fox.
- 5. A reasonable amount, at the discretion of the Mayor, be used to notify the public of this campaign, said amount to be from the Municipal Budget.

This will be in recognition of the effort of Terry Fox. We will have a special Terry Fox day and the Mayor sought Council's guidance for such further means of recognition as Council may wish.

- (1) THAT Council approve the working drawings prepared by the consultant.
- (2) THAT Council adopt the schedule outlined in this report and authorize the respective calls for tenders for the general contractor's work and for subtrades' work as outlined.

  - 1. Council Requested Report Items

The Municipal Manager provided a status report from the Director of Planning on reports which have been specifically requested by Council. The list of projects does not reflect the total work load in the department, but is merely a collection of assignments that are directly related to Council's request for information on various matters.

The Health Department is the only other department that is working on a report that has been requested by Council. The matter currently under review is the discharge of polychlorinated biphenyls into the Fraser River by Belkin Paperboard Limited. The Federal Government has conducted a survey which includes resident fish and bottom sediment. Staff is now following up to insure that this information is forwarded to us as soon as possible.

The Municipal Manager recommended:

(1) THAT the report of the Director of Planning be received for information purposes.

The Municipal Manager provided a report from the Director of Planning regarding the proposed sale of the subject municipally owned property at Canada Way and Willingdon Avenue.

The Municipal Manager recommended:

- (1) THAT Council authorize the Municipal Engineer to prepare the terms of reference and invite proposals for a Soils Consultant to provide specific recommendations on the proposed development of the subject lands. The cost of the Consultant is to be charged to Code 70, Land Assembly and Development, of the Capital Improvement Program.

5. Proposed Amendment to By-law No. 5533
"Burnaby Unsightly Premises By-law 1969"

The Municipal Manager provided a report from the Municipal Solicitor on a proposed amendment to the subject by-law.

The Municipal Solicitor reported that Section 2 of By-law No. 5533 presently provides that "no owner or occupier of real property shall allow the said real property to become untidy or unsightly". prosecution based on this section of the by-law was dismissed by a Provincial Court judge on the ground that while the property in question was certainly unsightly, the prosecution had not proved that it was the defendant who had permitted it to become unsightly. Following this decision, we recommended an amendment to the then Section 870(h) of the Municipal Act empowering Council to prohibit owners or occupiers of real property from allowing the property to remain untidy or unsightly. The recommended amendment received support of the U.B.C.M. and it was included in Bill 54, the Municipal Amendment Act, 1980, which received Royal Assent on 1980 It is recommended that Council adopt the proposed amendment, now authorized by Section 932(h) of the Municipal Act, that "no owner or occupier of real property shall allow the said real property to become or to remain untidy or unsightly".

The Municipal Manager recommended:

(1) THAT the recommendation of the Municipal Solicitor be adopted.

6. Lower Mainland Archery Association Taxes on land used by Association

The Municipal Manager provided a report from the Parks and Recreation Administrator regarding the Lower Mainland Archery Association taxes on land used by that Association.

The Parks and Recreation Administrator reported that although the activities of the Lower Mainland Archery Association are recognized as being of value, staff feel that based on available information, there would be little benefit to the residents of Burnaby if the Association was financially supported by the Corporation.

Because of the high tax levy on this land and little chance of the club increasing in size, the club will not be able to finance its operation in the future.

Presently, tax exemption to regional sports associations is not provided unless there is a direct service or benefit to Burnaby.

In view of the Association's make-up and mandate and the ultimate weak viability of the group at its present location, it is recommended to not provide financial support. Staff feel that the associations should pursue support from the provincial and national bodies.

The Municipal Manager recommended:

- (1) THAT the recommendation as contained in the report from the Parks and Recreation Administrator be adopted.
- (2) THAT a copy of this report be sent to Mr. Phil Talbot, Secretary-Treasurer, Lower Mainland Archery Association, 1923-7th Avenue. New Westminster, B.C., V3M 2L4.

9. Fire Services - Discovery Parks Incorporated and Simon Fraser University
(Cross Reference: Rezoning Reference #9/80)

The Municipal Manager provided a report from the Director of Planning regarding fire protection relative to Discovery Parks Incorporated and Simon Fraser University.

The Director of Planning reported that it is proposed that, after due consideration of the overall Fire Prevention Control Study criteria and recommendations, Council would pursue the appropriate fire protection services for the S.F.U./D.P.I. area without the attendant haste of necessarily attaching this issue to the S.F.U. site D.P.I. Therefore, fire protection arrangements would not be rezoning. included as one of the prerequisites to a reintroduced S.F.U. site D.P.I. rezoning proposal. Council should realise that in these circumstances the municipality will be responsible for the costs of providing fire protection at a future date for the D.P.I. site whether this fire protection takes a form of a firehall on the mountain or other appropriate form. Since S.F.U., by its proximity, will benefit from any additional fire protection services on the mountain, it would be appropriate to pursue the co-operation of S.F.U. in providing as much assistance as they are able on this matter.

The Municipal Manager recommended:

(1) THAT, in the light of the Director of Planning's report, Council permit the S.F.U. site Discovery Parks rezoning to proceed on the basis that adequate fire protection would be provided in due course following completion of the "Fire Prevention Control Study and Master Plan".

The Municipal Manager provided a report from the Director of Planning concerning the proposed acquisition of the subject property.

The Municipal Manager advised that in his opinion negotiations at this time be commenced for only that portion of the property that is required for the development of the Municipal Trail System, i.e. Stage 1, and that this be pursued on the basis of the current A-2 zoning designation. The Manager supports the eventual purchase of the entire property but is not prepared to recommend that such action be taken at this time, given the timing projected for the need for the property.

At the same time, the Municipal Manager is of the view that none of the property should be rezoned from Agricultural District (A2) to Light Industrial District (M5) as requested by Mr. Hean on behalf of Mr. and Mrs. Love.

The following are the recommendations contained in this report:

- (1) THAT authority be given to:
  - (a) advance in priority the "First Stage",
  - (b) negotiate for the purchase of the "First Stage" portion only of the subject property.
- (2) THAT a copy of this report be forwarded to the Parks and Recreation Commission for information.
- (3) THAT a copy of this report be sent to Mr. Arnold F.C. Hean, Q.C., Hean, Wylie and Company, 600 Burnaby Centre, 4211 Kingsway, Burnaby, B.C., V5H 2A8.

12. Rezoning Reference #28/80 4305 Halifax Street and 1770 Douglas Road

The Municipal Manager provided a report from the Director of Planning with respect to the height of the highrise building in this proposed development relative to the height of the existing highrise building on a site south of Halifax Street.

The highrise tower proposed under Rezoning Reference #28/80 consists of 22 typical apartment floors plus a plaza level and communal amenity level and a partial storey penthouse level, for a total of 24 floors. The penthouse level contains four dwelling units and its perimeter walls are set back considerably from the principal walls of the tower, so that it is perceived as a part of the roof form, rather than as an additional storey. The total overall height of the building from plaza level is 72.6 m (238 feet).

The Brentwood House building to the south of Halifax, at 1850 Rosser Avenue, consists of a single tower, 18 storeys in height, with a total overall height of 65.8 m (216 feet).

The Municipal Manager recommended:

(1) THAT the report of the Director of Planning be received for information purposes.
